Gordon has been reaching out to landowners in the area who may volunteer their boats for Mystery Bay buoy maintenance. There may be missing buoys. Gordon has GPS coordinates. 	Forage Fish (Jeff) - sampled today. Did not notice eggs but sent to the lab for analysis. Neil thinks some eggs found in last Fort Townsend sample. Frank says 1/17 Fort Townsend sampling. Betsy asked for coordinates of beaches MRC is sampling. Disco Bay sampling 1/19. Jeff and Amy will process samples.  Kelp – no report. 	Rain Gardens, Crabber outreach - no reports.  Chair noted he was off track on agenda and with members permission he would take things out of order.	
Recent Meetings Reports	NWSC Meeting - short meeting. Draft Kelp recovery plan was announced.  Strait ERN (Neil) 100k of funding #1 project, Lower Elwha revegetation of former reservoir site. Jamestown project also received funding. Neil and Emily Bishop involved with Jamestown project. Check Strait ERN website for awards.	
City of PT Outfall Pipe Replacement	PT Outfall (Nam) - Nam distributed draft letter for MRC consideration. Nam asked for comments on the letter. He will bring back a revised draft for the full MRC's consideration. He noted the tone is intended to reflect MRC is here to be helpful. Members provided comments and thanks to Nam for drafting the letter. Greg noted this letter would be sent to Commissioners for their consideration. Greg suggested before a letter is sent, we should have City present to the MRC. He also is concerned about comparative costs with Port Hadlock project - he did not see the comparison as germane. 	Solenne noted advanced treatment technologies and need to look at more current technologies and associated costs. She does not get a sense that newer technologies were addressed by the City.	to Nam.	
	Neil - our main concern is with habitat impacts. How do you avoid that? Neil had questions about increased capacity as city grows, newer regulations, etc. Tribe is wondering whether there's a way to avoid replacing the pipe.		
	Nam agrees City Engineer should be invited to present alternatives as soon as possible and then a second presentation on the Mitigation Plan. City Council will be having a workshop on the sewer outfall this Spring members may want to attend /participate.		
	Nam backtracked to cover history - this started because MRC learned that City was going to replace pipe and so MRC responded to pipe replacement. MRC wanted to provide BAS on how best to do that. However, City then revised WWTPlan which looked at alternatives. MRC had not realized alternatives were still on the table. Letter is to provide constructive path forward. Focus now is whether replacement is necessary.		
	Judy gave update that City Engineer Dave Peterson is happy to present after the Council workshop.		
	Bryan DeCaterina did the habitat survey in his capacity with MSA. The mitigation plan has been provided to City and should be available soon.		
	Members provided input on the Draft letter. Nam doesn't see there's a rush. Doesn't know that letter will change anything as decision has been made. Judy noted MRC has already had an influence – City is reexamining costs. Also, it's not unusual for City/County's to reconsider/amend previous actions.		
	Q: Status of Paper Mill water use/reuse - Nam noted, City Engineer covered that at the Council Hearing. Since mill paper is used for food products reclaimed water cannot be used.		
Speaker: Lisa Kaufman	Shore Friendly (Lisa Kaufmann) - she is the Nearshore Program Manager for the NWSF, formerly with DNR where she focused on creosote removal. NWSF is entering a new phase of shoreline landowner outreach so she's meeting with MRCs. Presentation gave an overview of Shore Friendly - Shoreline Armor Reduction Outreach & Incentives. It's a regional social marketing program aimed at encouraging landowners to be good stewards. Encouraging armor removal, the differences between soft vs. hard armoring, and avoiding the need to armor. 2015 Shore Friendly began in a few counties. Moved to ESRP and went regional, now every county in PS region has a Shore Friendly Program.		
	Summarized impacts of armored shorelines and functions of natural shorelines. With SLR and continued upland development we squeeze Nearshore habitats out. Lisa described program goals and objectives including removing barriers. She has helped from initial assessment through design, permitting, and implementation. Multiple funding sources.		
	Progress of NWSF in collaboration with MRCs: Over 200 site visits and 3,930 linear feet of armor removed since 2017, 13 designs, 1,100 landowners reached thru community forums.		
	In Jefferson County: 182+ landowners reached through workshops. 61 site visits. 3 designs. No removal but anticipate 900 linear feet in 2021-2022 (Discovery Bay projects). Funding is a barrier. One of the designs was for Beckett Point but project died out as cost benefit was not worth it. Shine area project also died out. Site visits are conducted by a coastal geologist.		
	Moving forward, a shift in focus from removal to reduction of armor demand- find resources to help vegetate and improve drainage management or relocate house/septic to prevent the need for armoring. Septic fields are often the limiting factor in removing bulkheads.	Judy to cond ADA contact info	
	Goal to conduct workshops with Land managers/planners. Judy suggested American Planning Association Quarterly forums.	Judy to send APA contact info.  Shoreline Landowners

PUBLIC COMMENT	None.		
BoCC REPORT	Commissioner Brotherton – Short legislative session. Last month he noted Shore armoring bill proposed by State SB6147 - he has researched it. It would amend an existing RCW to prioritize removal of shoreline armoring. Other bills of note HB2427 adding Climate Change to GMA. HB2550 going from no net loss to net ecological gain. He would love to discuss further in future. Penn Cove mussels will move out of Quilcene Bay - he would like a future speaker on the topic. Gordon noted Skokomish Tribe had objected to Penn Cove's permit extension. Neil noted that though he is "tribal rep" he only represents Jamestown S'Klallam Tribe. Gordon will call Brotherton to discuss further. County wrapping up CAO Ordinance update. Beginning SMP periodic review. Proposing a citizen advisory group to help identify issues to focus on the SMP.  Tom Madsen approached Commissioner Brotherton with concerns that MRC volunteers may have crossed private property on lower Discovery Bay - Bob noted NWSF has a grant for that area. Sarah noted they may have inadvertently strayed off-	Staff to schedule speaker on Penn Cove topic.  Gordon to call Commissioner Brotherton re: Penn Cove	

	site. Boundary is unclear. For now, the NWSF and MRC has abandoned the site.		
Speaker: Scott Pearson (WDFW)	Speaker: Scott Pearson (WDFW) – Topic: Pinniped diet, abundance and trends in the Salish Sea A controversial subject and becoming more heated overtime. We continue to learn more. Scott is a research scientist in the habitat program. He provided an overview of status of pinniped in WA state. The pinnipeds of focus are harbor seals, Stellar sea lions and California sea lions since they have the greatest impact on salmon populations. Tonight, he will focus on harbor seals including their abundance, range, stocks, habits, diet, etc. Trends since the Marine Mammal Protection Act 20 years ago, population grew and then began to level off. In 2000 surveys stopped with the exception of opportunistic survey 2010. In 2019, with tribal funding, conducted another survey. Based on last two surveys, it appears the population has stabilized. Scott responded to questions about Transient Orca eating harbor seals and survey methods. Stellar sea lion population continues to grow. California sea lion populations hit asymptote (population stabilized).		
	In re: diet, concern that pinnipeds diet includes Chinook and Coho salmon. He noted predation is only one of many factors affecting salmon recovery. It's a complex food web. 2016 paper by Chasco et. al. found pinnipeds consumption of salmon had increased significantly in recent years and that their consumption accounts for more than killer whales. But the paper was criticized. New model developed. Found diet varies significantly by season and location, males vs. females. 2016-2018 sampling focused on juvenile salmon consumption. Highly diverse diet. Juvenile chinook salmon only about 1-2% of their diet. So why the concern? Calculated that out, it's about 1,425,000 juvenile chinooks eaten per month. But fish size has a large influence on the consumption estimates. Working on draft paper now that takes size of the Chinook into account. If we do something about harbor seal population, could we alter salmon mortality trends, or would they simply be eaten by something else? Q&A ensued. Seals are being euthanized at Willamette Falls and Bonneville Dams.

	Oly Oyster (Neil) Got permits from ACOE for Discovery Bay. Will figure out a schedule and coordinate volunteers to spread the shell.

	previously. County officials are fans of adaptive management, but		

that can be difficult with limited resources. CAO comes out of GMA, and has precedence over GMA. Commissioner Brotherton attended a meeting with WA State Department of Ecology (Ecology) regarding the **Shoreline** Master Program (SMP) for a periodic update. He reported that it went great. Also in attendance were Tim Gates (policy manager) and Michelle McConnell (local partner), to collaborate with Ecology. County representatives expected to make a case for easing the burden on builders. Ecology, however, came with data on shoreline permits Jeff. Co. has issued, saying that Jeff Co. had way too many conditional use permits for mooring buoys compared with other counties. Usually 60% of permits issued are shoreline development permits, but the ratio in Jeff. Co. is "upside down," meaning that too many permits in Jeff. Co. are conditional. Ecology will work with Jeff. Co. to ease regulations. No net loss is the golden rule but it is heartening to go into the SMP update with Ecology on the same page. Neil clarified understanding of the numbers on the handout Greg passed around demonstrating the ratio of use permits. Too often Jeff. Co. goes to conditional use for basic shoreline development. Requiring conditional use for a residential mooring buoy costs the county a significant amount of overhead, and the process should be much simpler for a basic shoreline use. Solenne Walker noted other permits required for conditional use which tie up resources (Hydraulic Project Approvals (HPAs), Army Corps of Engineers). Timeline- still early in the process. County officials are planning to create a task force to identify issues in the planning phase. Commissioner Brotherton will let the MRC know when this task force is forming, but it is not open yet. Update on proposed construction at the Point Whitney boat ramp. Washington Dept. of Fish and Wildlife (WDFW) received \$540,000 in funding through the Recreation and Conservation Office (RCO) to replace the Point Whitney boat ramp. This is an important ecological area, but there have been no proposed site alternatives or design alternatives. The current design is for a 12ft wide, 134ft long boat ramp with concrete mat shoulders. Commissioner Brotherton will be meeting with community members who are excited about the project. County officials feel neutral so far, but are unsatisfied with the lack of alternatives proposed. WDFW has said that for the amount of money available, this is the only option besides not rebuilding at Herb Beck Marina (Quilcene) is closest alternative boat ramp. Triton Cove would be the closest to the south. Bryan DeCaterina reported that there is a healthy eelgrass bed in the vicinity. The new boat ramp would go right into it. The boat ramp is being rebuilt because it is in disrepair/almost nonexistent. Bryan only sees people walking dogs or diving at that site. Several members posed the rhetorical question: if you replace the ramp with the same design as the existing ramp then who's to say it would function better? Neil asked how much use it would get. Roy says it used to be used quite a bit more, but much less now as WDFW doesn't have a Point Whitney office anymore. Bryan noted that the Quilcene marina has long lines during fishing openers. Emily Bishop noted that we shouldn't necessarily be opposed to construction of public access boat ramps, because they may be a preferred alternative to permitting private access points. Solenne pointed out that public access points require lots of other resources like parking and bathroom facilities. She stated that ramps promote fuel based water uses. WDFW has started the permit process and this project is still in the beginning phases.

#### **Comments on NWSI retreat questions**

Jeff Taylor- Every year there is a retreat to discuss the Northwest Straits Initiative (NWSI) mission. The NWSI is our parent organization, which is in place to help us with projects. They want to know how to better support us, and talk about what

MRCs can be doing better. Lucas (director of the Northwest Straits Commission, part of NWSI) wanted feedback before the next retreat about what they're doing well, or how they might improve. The following discussion addressed the list of questions.

- 1. Regarding educating county leaders and recruiting county elected officials:
  - Jeff believes we do well with county involvement and recruitment compared to other counties, while other counties may be stronger at getting more people involved with new projects.
  - Greg thinks we do a great job of educating county leaders on the need for the MRC, and full-time staff support.
  - Neil thinks we get good involvement from elected officials through Commissioner Brotherton and Port Commissioner Pam Petranek.
  - Judy says the MRC has been on Port Townsend City
    Council's radar on and off. Public Works is aware of the
    MRC. Cheryl, the previous MRC Coordinator, used to do
    periodic presentations to keep City Council informed- not
    sure when the last one was. Judy got involved with the MRC
    during an SMP update to learn more during the process.
    Judy says it's hard to get on the City Council agenda, so the
    most effective way is for the MRC Coordinator or otherwise
    rep to use the City's public comment period to give an
    overview and state interest in providing a longer
    presentation if they request it on their agenda.

Regarding recruitment of non-MRC volunteers for projects, a number of volunteers come from the WSU Extension's beach naturalist course, and volunteers specifically for rain garden projects come from the master gardener course. Beach naturalists volunteer on forage fish teams and with olympia oyster activities. Neil thinks we're doing well.

- Monica thinks many projects don't require more volunteers but looking into recruitment strategies may become more important as we take on more projects.
- Solenne asked if Jeff. Co. has an active Shore Friendly program. Darcy McNamara used to run it. May be a useful tool.
- Jeff would like to brainstorm more recruitment ideas. Betsy Carlson says Port Townsend Marine Science Center (PTMSC) may be source but just need to coordinate. Jeff wondered if we know any American Canoe Association (ACA) certified kayakers.

Regarding holding joint MRC meetings, we didn't do a joint MRC meeting last year. Two years ago we had a potluck joint meeting with Clallam and Island Counties. In the past, we've done a joint meeting with Clallam MRC hosted at Jamestown. Island County has meetings on the same day as us (first Tuesdays). Joint meetings are usually in the summer.

In terms of seeking opportunities to work with Tribes, we have some engagement with the Tribes through projects with Neil and Emily. Troy would like to include the Tribes more. Jamestown S'Klallam Tribe (JSK) is involved in the olympia oyster project. Tribes with Usual and Accustomed fishing areas within east Jeff. Co.: JSK, PGST, Lower Elwha Klallam, Skokomish, Suquamish, Tulalip, Swinomish, Lummi. Tribal connection is okay but could be improved.

We have good support from county staff. (Addressing a similar question about identifying staff who are enthusiastic is more applicable to other MRCs which feel less supported.)

Regarding development of outreach tools to raise awareness of the MRC, we could do better. Greg noted that while Digging for Dinner is an excellent event, it is not clear to attendees that it is an MRC event. We need to do a better job showing ourselves. Neil noted that the olympia oyster story in the paper is an example of how we can raise our profile, and the paper is always looking for stories. PT Leader writer Lily Haight has an impressive writing ability. Roy asked if we have signage at rain gardens. Some rain gardens have signs, but they may be needed at newer ones. Larger conversation to be continued.

Regarding recruitment of local, state, federal decision-makers, Neil thinks we have good local representation through county officials as local decision-makers.

- 2. In terms of MRC member recruitment, we recently had a surplus of applicants. Neil is impressed and appreciates everyone stepping up. Turnover is worrisome but we've gained some really good people.
- 3. We don't have a problem cultivating MRC leadership. We have opted to have two chairs. Our co-chairs appreciate being able to trade off leading meetings. It was noted that one county has had a hard time finding a chair. One exercise we can do that another county has had success with, in terms of identifying project leads, is to put up a large piece of paper on the wall and have members place dots next to the projects they would be interested in leading. This was a useful exercise to determine project lead roles and identify gaps.
- 4. MRC members are looking forward to the April  $3_{rd}$  symposium, to generate project ideas. Brenda Johnson noted that this is a huge topic, and there needs to be focus on a gap analysis on regional projects that aren't happening, for MRCs to step in. It's hard for new members to propose new projects until they understand where there is need, so the April  $3_{rd}$  symposium will be useful. Jeff agrees that the symposium will help to see what other groups are working on, and maybe use some of their ideas.
- Judy gave some history on the early days of the MRCs.
   Members picked great projects but didn't consider the long-term commitment being made. There needs to be discussion about end dates when scoping out new projects. That's one reason why our group has limited capacity for new projects, because continuing projects still require resources.
- Monica says having a lead for the Education & Outreach subcommittee to help discuss projects and continuing efforts will be helpful. Organizing a retreat for our MRC may be good to get ideas flowing. Something to look at this year or next.
- 5. The group was asked if they have any new project ideas.
- Greg proposed forage fish monitoring at the Duckabush River estuary before the large restoration project happening down there. Judy noted that the Northwest Straits Foundation (also part of the NWSI) may be able to get money, but we should consider whether our staff have the capacity to oversee another fund source.
- Troy proposed a herring hatchery, involving growing eggs in the bay. The angler's club is doing it, and there's one in Mats Mats Bay for bait.
- Betsy is open to the idea of looking at joint projects with PTMSC.
- Jeff's neighbor wants to check Discovery Bay for derelict gear. In the past others have reported it's too expensive to remove gear in Discovery Bay. High schoolers have come to our meetings in the past looking for projects to do with their underwater drone. Maybe students would be into visually surveying. Technology is getting a lot cheaper. Multiple school age groups may be into this. There is one robotics group at the high school, and a separate group does the underwater robotics. Betsy may know who to connect with. Solenne is our rep to the Maritime Discovery Schools (MDS) program. Sarah Rubenstein (lead of MDS) would be the one to ask about engaging kids. They're always looking for ideas for older kids. Retrieving lost gear is a separate issue because it requires diving, boats, and disposal areas, but mapping alone is very useful. Tariffs have hit geoduck industry so aquatic land managers are coming up with projects for state divers, and Solenne is finding that having mapped areas on hand is very useful for speeding up recovery actions. No one else volunteered to assist with this project at this stage, but Solenne is willing to liaison at the MDS meeting in April.
- Judy mentioned the Skillmation program for mentoring students. It involves logging in to the online platform and indicating your interests and ability to contribute, then they connect you with students who are interested. She knows there's a science teacher who is looking for speakers to come.

- Pam asked what studies have been done on the health of Quilcene Bay. There is concern by residents and frequent beach closures. There's talk of things changing but unsure whether this has been studied. Solenne noted that the County Health Department does monitoring. Neil said herring surveys are conducted by WDFW, there are water quality reports from WA Department of Health, Environmental Health does fecal contaminant source tracking, and Ecology does sediment monitoring. Judy mentioned that Sound IQ may have more monitoring information.
   Cliff Moore noted that WSU Extension directors received an
- Cliff Moore noted that WSU Extension directors received an email that college students are looking for capstone projects, which may be an opportunity to reach out to students. A group of students recently went to PA for code revision projects. Judy said Huxley on the Peninsula has students as well. Neil has worked with students from UW School of Environmental and Marine Affairs in the past.

6. Regarding how the NWS Commission can help, it was noted that supplies like GPS units and forage fish sampling equipment are nice to get.

#### Comments on MRC symposium agenda

Neil stated that it looks like a useful agenda. Brenda gave feedback that it would be helpful to have examples/MRC case studies which have come to fruition and are thought to be successful. This way, people can get the story from start to finish and see what was successful (or not). It helps to know what has been happening on the ground. Greg reports that he received very little on-boarding, and that orientations for new board members is helpful. A book of past projects may be useful.

Neil has gone back through NWSC newsletters for historical context. He saw a presentation about olympia oyster restoration near Anacortes at an MRC conference, which inspired him to work on them.

Brenda commented that there are project descriptions on the websites of all MRCs but the same project is described in very different ways, such that you can't even tell that it's the same project between counties. A time series analysis of what we've accomplished would be useful. Jeff agreed, and that that would also be a useful project for seeking funding. Solenne commented that the different MRC websites are very useful.

#### Current and Upcoming Projects

**Sewer Outfall** (Dave)- There will be a workshop with City Council on Monday March  $9_{th}$  6:30pm. Tonight is an overview, but Dave offered to come back for a more in-depth presentation.

Dave is a city engineer but environmental engineer by training with expertise in wastewater. There is a leak in the current PT sewer outfall, and Ecology has ordered the city to replace it. The city was working on it 10yrs ago but got a new permit which requires fixing it. They worked on a new facility plan to then replace the outfall. This went through City Council, the State Environmental Protection Act (SEPA) process, and was accepted by Ecology. Next phase of permitting is with the Army Corps of Engineers.

The process for the outfall itself will go through SEPA. The plan is to replace the pipe, restore eelgrass, and monitor recovery for 5 years.

Currently, the outfall is thought to be a thriving environment, not causing any adverse impacts. The area experiences lots of mixing, and there has been some controversy over whether there is a gap in bull kelp. Bryan noted that Marine Surveys and Assessments did not find a gap in kelp, but actually kelp was most dense at the outfall.

The least expensive alternative is to take material on a barge, lay the pipe, put material back and replant. Kelp grows because of substrate.

There will be impacts from construction, and continuing impacts through wastewater. There have been comments on nitrogen in the wastewater which affects kelp. Problems occur when nitrogen

causes an algae bloom and the algae dies and decomposition consumes oxygen. Our outfall has diffusers and is in a mixing zone. It is required to meet water quality standards for mixing. Tests are done at slack tide, so there is even more mixing when currents are distributing water. He doesn't think nitrogen is a significant impact at our outfall because there aren't huge land-based inputs. He believes this is a bigger problem in South Puget Sound.

Is there a less detrimental way to construct the outfall? Microtunneling is tough because there is a lot of cobble at this site. It is also risky as it costs several thousand dollars to investigate whether it's possible. If you hit an impenetrable rock you have to start the tunneling process over.

Capacity is related to tide level. Long term this will be a pipe we can pump against higher tides. The proposed design is an upgrade from 18-inch pipe to 24-inch pipe.

The cost will be \$3-4 million for cut and cover. Cost would be twice that to microbore with the possibility of failure, and they would still need to cut-and-cover where the diffuser would be placed. On-land options aren't feasible because there isn't a use for the water. Port Hadlock is looking at an option that will cost \$15 million, which would be much more expensive in Port Townsend since the city has a larger population. Aquifer recharge was addressed. It is not possible to line existing pipe, because a temporary pipe would be needed and would cause its own impact.

They could go out another 500 ft but that involves impacting more kelp, without getting a significant change in dilution. There may be better uses for the amount of money it would take to extend the pipe.

Bryan noted that since restoration is such an unknown for kelp species, impacted kelp would probably be considered a loss.

The group agreed it would be great to get a longer presentation.

**Kelp Monitoring** (Jeff) - Someone asked a question about kayak insurance to Don Hunger (NWSF director). In the future, we may need an ACA certified guide present for surveys. Alan Clark (Clallam MRC) is working with Dana Oster (NWSC project manager) and Don to figure it out. There is an associated expense, so either Don will change his answer about requiring this, or we need to look at funding. We may look to the kayak guide guy at Fort Worden, or another connection who Betsy knows. This may end up being a paid position.

**Forage Fish** (Jeff) – WDFW is piloting a tablet- and smart phone-based form for data entry and management, which will save an hour of data entry for the person who used to send in data

Looking at starting a new index site at Dabob Bay. Lisa Hillier is coming up on the  $18_{\text{th}},$  to assess the site as well as train MRC volunteers in using the new form. Sarah Fisken will recruit new volunteers.

The MRC currently has one index site (Discovery Bay), and will be doing one last year of monitoring at Fort Townsend State Park.

**Rain Gardens** (Monica) - Bob worked with a city engineer to list potential sites for the next rain garden installations. The master gardener coordinator sent postcards to 80 professionals about the upcoming rain garden training workshops. So far, 11 volunteers have also signed up, committing 10hrs of volunteer service.

**Oly Oysters** (Neil) – This year they will add shell at Discovery Bay at the spit and lagoon side and under the power lines. Neil will talk to Gordon about getting shell from Taylor Shellfish. BOCC REPORT	Commissioner Brotherton – Supporters of the Point Whitney boat ramp project from Brinnon solicited a letter of support from the Skokomish Tribe, which has allowed the project to move forward. County staff had hoped to encourage an above grade boat ramp design, but boat ramp will go forward with the design as is.  Updates regarding the COVID-19 pandemic: recreational fishing opened today. Jefferson County is one of ten counties with the option to apply for a variance to move on to Phase 2. County officials are moving towards this with measured progress. Kitsap has already submitted for variance, but Jefferson is still considering pros and cons. The County is able to choose which aspects of Phase 2 they would like to apply for, meaning they don't have to commit to all of Phase 2 all at once. There will be a public GoToMeeting tomorrow (5/6/20) with City of Port Townsend and Board of Health to discuss whether to apply for variance. Jefferson Healthcare and Public Health Dept. will comment at the meeting. Jeff. Co. Public Health Officer Tom Locke will put a proposal together to go through the Board of Health, which can make any modifications deemed necessary to send to the Board of County Commissioners (BoCC) for final vote. Given the proximity of Jeff. Co. to Seattle, tourism is a big concern. We don't want to move too fast, or endanger the community, but at the same time, lots of people say we need to open. BoCC is looking for feedback on the nuances of different sectors to understand which ones may open safely.  Betsy Carlson asked about the Point Hudson breakwater. Given that the Wooden Boat Festival has been cancelled this year, maybe this is a window to replace the breakwater without disrupting community events. Greg noted that this was a good point, and he is having conversations with county staff about what opportunities may arise to improve capital while things are shut down.		

	Jeff Taylor said he appreciates the good information coming from Dr. Locke on KPTZ Monday mornings. Greg praised the leadership the Public Health Dept. is providing during the COVID-19 pandemic.

	Northwest Straits (NWS) Foundation Opportunity Fund suspended due to COVID-19 pandemic.		
	Judy Surber is stepping back from the MRC while City employees are furloughed, due to her corresponding increase in workload. She has requested to be kept out of emails.		
	Monica is looking into liability concerns for our projects. WSU insurance cannot cover MRC activities. Cliff Moore (WSU Ext. Director) is directing us to contract out dive work while liability coverage is unclear with the County. Working on the beach may be covered under L&I through the County, but on-the-water activities such as kelp monitoring might not be covered once volunteers leave the shore. L&I suggested looking into maritime insurance.		
	Gordon King believes any activities out of a boat come under the Jones Act, therefore will not be covered by L&I. Sarah said that may just be for commercial operations. Given that L&I is insurance for employees, there was a question of why L&I covers volunteers at all.		
	County HR explained that MRC members are considered to be unpaid employees by Jeff. Co. so that's why we are covered under L&I for activities off the water. Bryan DeCaterina said that at his work they have USL&H insurance to cover anything on-the-water.		
	Bob explained that WSU doesn't cover MRC volunteers, but does cover volunteers for programs directly under the WSU umbrella.		
Presentation: Nam Siu	PT Outfall Overview (Nam) – There has been lots of turnover since the last update on this project, so it was time for a refresher on the background and status. The MRC exec committee wants Dave from the City to present on this again, but he and others from his office have already presented on this repeatedly. Nam thinks we shouldn't request another presentation until there is something new to present, such as a mitigation plan, so as not to waste anyone's time.	MRC members should make notes about questions or concerns regarding the outfall pipe replacement proposal, to ask during future presentations or to pose in public comment letters.	
	The purpose of this effort by the MRC is to review the City of Port Townsend's proposed project for a new sewage and storm water outfall pipe. Nam brought this to the group last year because the location of the outfall is adjacent to the subsection of kelp bed we monitor at North Beach. The kelp bed at North Beach is the largest bed in Jeff. Co. and one of the healthiest in the state. Last year, the City of PT started engaging with regulatory agencies to replace its sewer outfall, which is currently ~1000ft offshore from the North Beach boat ramp due north. Waste is treated to secondary level (tertiary involves removal of nutrients). The current pipe is in bad shape; it is broken and leaky and visible at low tide. People often misidentify the Chinese Gardens outfall, which is further east from the boat ramp, but the sewage outfall is directly next to the ramp. The outfall pipe needs to be repaired, and the City has proposed to replace it. The latest proposal involves shortening the pipe closer to shore (though Nam was not sure not sure if Dave had an update on this).		
	There are two main concerns regarding this proposal. The first is continued long-term discharge of waste into a kelp bed. Published literature shows detrimental effects of nutrient loading on kelp. The second concern is the acute effects of disrupting habitat to install the new pipe. The last proposal involved digging a 40-50ft wide swath 1000ft from the boat ramp through eelgrass surfgrass and kelp, with additional buffer impacted. These species of submerged aquatic vegetation are of significant concern for the state, and are nursery habitats for juvenile marine species. The MRC should review this project to help the City complete its goals in an environmentally friendly way.		
	Frank noted that he attended a public comment period in the past where City commissioners appeared to be taken by surprise that the public had concerns over the proposed pipe replacement. City officials referred to a consultant report that was completed at some point - Frank wondered when that was completed and what the goals of the report were, such as		

whether the consultants had been asked to consider alternatives to replacing the pipe. Nam believes that that is still an unanswered question: does the pipe need to be replaced at all? Are there any viable alternatives to offshore discharge? The consultant report was completed in 2009, at which point they concluded that other options were too expensive and not feasible. Nam believes that information is now out of date, and technology has decreased the price of upland options within the last 5+ years.

The City proposed this project to state agencies at the end of 2009. The state Dept. of Natural Resources (DNR) and Dept. of Fish and Wildlife (WDFW) responded to the City's pre-project application with a letter making the same points that we're bringing up now. It's concerning to Nam that the City has been aware of these issues since 2010 but has not taken steps to address them. In the meantime, other projects took precedence, so this was on the backburner. But now the issues with the pipe have gotten to the point where they need to address it. Unfortunately the proposal is pretty much the same as it was back in 2009, therefore the concerns are still the same.

The public hearing Frank referred to was held by the City to update its Wastewater Facility Management Plan, which was a required step prior to applying for an update to the pipe. Several people made comments and raised concerns at the hearing. City Council members were surprised by concerns because they were not familiar with the feedback previously given on the project. They were motivated not to slow down the process because the state Dept. of Ecology (DOE) was requiring an update to the Management Plan before further development and permitting. The public comment period was only 14 days so the MRC wasn't able to submit a letter

Further permits and future comment periods are upcoming. The outfall subcommittee is drafting letters to submit when a comment period opens. The MRC had discussed submitting a letter about the Wastewater Management Plan after the comment period had closed, but ultimately decided not to finalize the letter until the City comes back again to present on a mitigation or impact plan. It will be important to keep an eye on the timeline so we don't miss future comment periods.

Greg noted that we had also discussed that the MRC is advisory to the BoCC, so any letter the MRC wants to submit needs to go through the County for approval before submitting to the City.

Bob Simmons reminded the group that alternative strategies have been discussed at previous meetings. Nam said other options might not be possible, but so far the City's geotechnical analysis has only gone down to the tide line. 90% of the proposed length is subtidal, so the City needs to provide data about the subtidal area before saying alternative drilling techniques aren't viable.

Neil noted that consultants told the City that the pipe needs to be 10ft underground, which may be driving the width of the swath. 10ft seems like overkill. They said this was to protect the pipe from anchor strikes, which shows the consultants lacked local knowledge. Directional drilling may work if the area is not too erratic. Randy Johnson (Jamestown S'Klallam) looked into it in Sequim, where they directionally drilled for 600ft in Washington Harbor through mud. Directional drilling was tricky but ended up being cheaper and/or less complicated in the tidal environment.

Nam does not believe the pipe necessarily needs to be buried at all. Once you get subtidal there is not much sediment movement. No boats anchor at North Beach, certainly not ones big enough to damage a pipe. If the City invested in tertiary treatment, that may reduce the amount of wastewater and therefore the need for a new, larger diameter pipe.

Gordon reminded the group that DOE has upcoming changes in standards for wastewater treatment. Nam expanded on this, saying that DOE put out a warning last year that they are about to update requirements for outflow in Puget Sound. Nutrient loading is considered by some to be the biggest threat to the Puget Sound, by far. DOE knows this, and is about to change regulations for stricter standards. This is coming down the pipeline, so why spend money on a system that won't conform to the new rules?

Nam addressed a point made by Dave during his presentation at the March MRC meeting. Dave indicated that nutrient loading has only been shown as a problem in South Sound, but Nam pointed out that there have not been studies of nutrient impacts on kelp in the Strait. Puget Sound studies have been done in South Sound, so that's why those are

the areas with data showing it's an issue. Regional research (from California, etc.) shows a negative impact to kelp from high nutrient loads. High inputs of nutrients promotes weedy species that outcompete kelp. Nam and Neil discussed that the City has not been very clear about how close the current pipe is to capacity. Apparently, the City is projecting less water output in the future, in response to water conservation efforts, but has also rejected proposals to line the current pipe, citing a need for a larger diameter to accommodate future growth. MRC members should make note of questions to ask as the process moves forward. Steps remaining in the process: The City is in pre-app right now with agencies, to fine tune the project proposal. Agencies have raised concerns which have not been addressed. The City will submit an application to its own Dept. of Development for local permits which includes State Environmental Protection Act (SEPA) review. SEPA is where we will make public comment. Once SEPA determination is made, the City will need a hydraulic permit from WDFW, and simultaneously one from the Army Corps which coordinates with NOAA for federal review. It will also need a Shoreline Substantial or Conditional Use permit from Jeff. Co. WDFW and the County will have comment periods. It will be best to comment on local applications, but we can comment on state and federal permits as well, if we feel it is needed. Lingering question: do we know the anticipated application date from Dave? This will help us keep an eye on the comment deadlines. **No Anchor Zones** (Troy) – Emailing with the group to make plans. The Current and Monica to work on contracting Upcomina group intends to go out Saturday to replace the missing buoy, take out out the buoy maintenance. Projects winter buoys, and deploy summer buoys. Bryan may be able to use his work boat after talking to coworkers tomorrow. Weather is good, and more boats are anchoring out there every day. It would be good to get the big buoys back in this weekend in front of town, then move on to Port Hadlock and Mystery Bay. Don't need to dive to put in many of the buoys, but we haven't checked the connections for a year so would be good to check with a diver. Monica noted that Cliff says we need to contract the dive work, so she will continue discussions to see what is possible. Troy has GPS coordinates for the missing buoy. Kelp Monitoring (Emily) - Emily and Jeff attended a virtual kelp meeting in March organized by the NWS Commission to go over the 2019 kelp survey season. The kelp subcommittee met via Zoom to go over the protocol with new members and to make a plan for the beginning of the season. Tomorrow (5/6/2020) there is a virtual kelp workshop hosted by the Commission to prep for the 2020 field season, which will involve a safety training. The safety training will be recorded and mandatory for any volunteer to watch before going out on a kelp survey. The subcommittee will likely do a dry-run survey in May, then plan for the first official survey in June. Forage Fish (Jeff) – Continuing to take samples, which are stacking up because WDFW labs are closed. Training for data entry with an iPad was cancelled because of COVID-19. Jeff looked with a microscope app on his phone and didn't see eggs in the samples he's storing. They typically see eggs mid-winter at Adelma Beach. Rain Gardens (Bob) – Hopes to do 2 installations this year. Working with the City to identify potential sites before the COVID-19 pandemic began. The subcomittee will now consider public visibility, stormwater management, and maintenance (hopefully by an active willing landowner) for each site. The subcommittee should meet within the next week and a half to discuss site options. New subcommittee members are A rain garden at Cape George was initiated with money from the NWSF Opportunity Fund. Some plants have been purchased already, but then the funding was pulled. Work will continue with Commission funding as it was already underway, and fits within the grant's scope. Part of the plan was an educational activity, originally set to be a 2-day in-person training, but now scaled back to two half day online sessions. Hoping to carry that forward. Oly Oysters (Neil) – We have the budget to acquire shell this year, which we should do, but it may be challenging to plan a volunteer event to spread the shell. There will be a subcommittee meeting in the next couple of weeks, since we're getting into low tides now. Likely will be spreading shell in Discovery Bay in June/July. Gordon believes it will be possible to buy shell now and spread it later, but that discussion may

have to take place at the end of May. Shell spreading may not happen with the usual bag format. Gordon suggested a committee meeting on the 20<sup>th</sup> of May. Neil will start looking at potential days to put on the calendar for the seed drop off.

**Crabber Outreach** (Roy) – Met with Monica to discuss modifying outreach in light of the pandemic situation. They may stream the crabber outreach presentation online. Don't want people standing at boat ramps, or face-to-face interaction. Jason from the NWS Foundation suggested creating a video instead of the workshops.

Shoreline Landowner Outreach (Sarah) – Talked with Monica, and Melanie and Lisa from the NWS Foundation in March. Focusing on education but may do bulkhead removals as well, if potential sites can be identified. Hoping to run programs in late August-early September. The Foundation mailed informational postcards to new waterfront property owners. It is probably time to check back in with Lisa to see if anything else is going on.

**Education and Outreach** (Brenda) – After the March meeting, Brenda and Monica built on the 2019 Education and Outreach plan and drafted a strategic plan for 2020. In April, the team met a couple of times to brainstorm as well as revisit successes and challenges of past activities. Wanted to generate socially distanced ideas. There was discussion about whether to spend any, all, or only some of the 2019-2020 funding. The group distilled contract commitments for 2020 into a list of priority purchases and actions that need attention. It made sense to combine all education and outreach into one spending plan (sent as attachment in meeting reminder email). They welcome comments and revisions. This includes proposal to spend state money (\$9,900) which expires by the end of June. During this process, they retained a list of old and brainstormed ideas to draw from in the future.

Brenda reviewed the list of proposed expenses, which were split into 5 categories: ads, project videos, website update, print handouts, and booth updates. Even with proposed spending we still have \$1000 leftover. There are also federal funds available through September.

Neil commented that in the past the MRC produced postcards, which were nice because you could send them to others for them to learn and enjoy. Sasha Horst confirmed that it is possible to do such printing with the current funds as long as the required logos are displayed.

Jeff brought up an effort from the NWS Commission to improve communication about who we are and what we do. Sasha clarified that the NWS consultant is focused on overall the initiative, not specific MRCs or projects, but there may be opportunities for some common messaging. 1st phase is a communications audit to determine what's most effective. Then, an ad hoc communications committee will be formed which people can join if interested.

Gordon proposed that we should determine the target audience before creating project videos. Greg offered to assist with video creation and says the County's Facebook and YouTube accounts offer ways to get content to whomever we target. It would be great to host the videos directly from the MRC website but other platforms may be better for making their availability known. Greg noted that the County recently created a county-wide policy for creating social media accounts to have a process for getting information out there.

Neil observed that some projects don't have dedicated artwork such as kelp/forage fish (Olympia oysters and eelgrass have nice posters already). Brenda says there is kelp related artwork in the archives. Monica reports that it cost \$2-3k for previous artwork. This could be an option if people want to sacrifice video funds for artwork.

Bob clarified that the vision is for videos to be only 2.5-3min, that's why the budget for each is so low. They would be short and simple: describe a problem, state that our local group is doing something, and here's what we're doing. He suggested that Greg could edit even shorter clips to help them go viral.

Troy suggested money for a monitor to view microscope images at our booth. Sasha says that shouldn't be a problem for funding. Monica noted that Brent Vadopalas picked out microscopes with a USB output for this very reason. Could use laptops or buy dedicated monitors for this.

Recent Meeting Reports April NWSI meeting (Jeff) – Meeting and virtual retreat were held last week. A project is happening in Drayton Harbor similar to what we do.

GUEST SPEAKERS Rebecca Welti & Anna Young	How art can be used to communicate science: Both artists became are interested in art centered on plankton. Plankton's form and ecological significance make it particularly useful to communicate to "everyone who breathes".  They proposed outreach education ideas, such as a youth-created quilt. Kids could use scrap sail cloth to illustrate or color-in depictions of plankton (or another species depending on theme), which could then be sewn together into a quilt. The quilt could have a theme (e.g. plankton or kelp life cycles) and be displayed around Jefferson County. Kids could also sketch unlabeled plankton sculptures and could be asked to guess what the forms might be. 	Frank Handler likes the idea of using art to communicate science to people's hearts. He says we need to communicate better. Brenda Johnson encouraged Anna and Rebecca to meet with the Education and Outreach subcommittee. Bob Simmons recommended adding QR codes to informational placards with the artwork to lead interested people to the MRC's website and more information. The PT Arts Commission funds artists, to which Anna and Rebecca are already submitting proposals, and a partnership with the MRC may help secure funding.  Betsy Carlson suggested painting the Memorial Field fence. Art showcasing the life cycle of organisms served at local restaurants may particularly resonate.	
BOCC REPORT	Commissioner Brotherton – Update on the Black Point Master Planned Resort progress: Roadwork is being completed near Pleasant Harbor in preparation for surveying and LiDAR. They are removing vegetation to clear out overgrowth to get clear LiDAR to plan the buildings. The only permit so far for the project has been the vegetation removal permit.	
	Shoreline Master Plan update: Received a ~\$84,000 grant from WA Dept. of Ecology. There is a RFP out for a consultant to facilitate the upcoming task force and to provide assistance in drafting the update. County staff is evaluating 3 proposals - the process is going well. Categories for representation within the task force will be similar to representation categories the MRC uses and Commissioner Brotherton is hoping to have MRC members on the task force. Positions on the task force will be advertised in the Peninsula Daily News and on the Jeff Co. website.	
	COVID-19 update: Jeff Co. is currently in Phase 2 except for camping. Hoping to open camping by Phase 3. The county is tracking well, with one new case in the last 5 weeks from a child who was asymptomatic. If we continue having less than 25 cases per day per 100,000 people then we will move to Phase 3 within a few weeks. Public health officials are trying to encourage a cultural shift towards wearing masks.	
Port of PT UPDATES	Commissioner Petranek- Point Hudson jetty update: on June 24 <sup>th</sup> the Port will have its first presentation on a new design for replacing the Point Hudson jetty.	
	Point Hudson has been the site for traditional living and harvesting by native peoples, a saw mill, boatbuilding operations, and the military which built the jetty. 155 direct jobs come out of Point Hudson. There are 14 upland acres and a 56 slip marina with 1700ft of shoreline public access. They are working towards designating Point Hudson as headquarters for the Washington State Maritime Heritage Corridor. In 1994 there was a 2 year planning process which identified use goals for the area relating to marine trades and education, which are still priorities today.	
	The 87-year-old jetty protects downtown PT from erosion. Maintenance of the jetty is the port's highest capitol priority due to its importance to the community's economic vitality. The current structure is severely compromised, so it is being completely redesigned and re-permitted right now. Restoration is likely not an option. Replacement of both the north and south jetty is estimated at \$11M. The port's new executive director is looking at both federal and state opportunities to fund the project. The last resort would be community support. The new jetty is going to look similar. It will have a rock core and steel pilings to replace 300 creosote pilings, a 3ft height increase to account for sea level rise, and a public walkway on top. Hoping to get the project started in September 2021.	
	Neil mentioned previous concern over the organisms that currently live at the jetty, and saving what's there. Nam provided background that the MRC had been concerned about previous replacement designs that would provide less structure for organisms to live on, but the last proposed design was an improvement. He recommended that the port explore moving or cataloging marine organisms before construction.

	Forage Fish (Jeff) – No update, haven't been able to go out sampling yet.		
	No Anchor Zones (Troy) – Bryan DeCaterina and crew from Marine Surveys and Assessments put out summer buoys along the PT waterfront and cleaned off buoys in Port Hadlock. A videographer filmed the dive crew working in Port Hadlock. Buoys look good and things are going well. Gordon King is trying to get the MRC back to doing the buoy maintenance in-house and Monica is working on how that would be handled with county liability.		
	Rain Gardens (Bob) – Information was sent out about upcoming virtual trainings: Sept 9 <sup>th</sup> and 16 <sup>th</sup> at 2:30-4:30pm. Anybody is welcome to join. The target audience includes professional landscapers as well as high level volunteers. At Cape George, they're planning installation on June 22 <sup>nd</sup> and 23 <sup>rd</sup> . Due to safety precautions, installation will mostly be completed by WSU and MRC staff. The rain garden committee is invited if they want to come and the committee will meet soon to discuss projects. Hoping to install a rain garden in early September with the City of Port Townsend.		
	<b>Oly Oysters</b> (Neil) – The committee met on the 20 <sup>th</sup> . Looking at spreading 10-12 cubic yards of shell at the powerlines and lagoon areas where they spread shell last year. Pushing spreading of shell back to June 22 <sup>nd</sup> . Gordon says there may only be 6 cubic yards. Getting it up to Discovery Bay is the biggest challenge. The shell will be dumped in a designated area then volunteers will come back the next day to spread.		
	The committee plans to conduct a population survey at Discovery Bay in July or August. This is a potential volunteer opportunity. The group also plans to do a reconnaissance at some point in Dabob Bay near Sarah's house and in Mystery Bay at Griffith Point near Brenda's house to look for oly oysters. A local videographer is also creating a video on this project.		

	Education and Outreach (Brenda) – Met in May to commit to taking on new education outreach tasks adapted to COVID-19. Cheryl Lowe is working on updating the website, which she anticipates finishing in the next week or so. It will feature new pages for projects and updated member bios. Brenda, Sarah and Monica are working on updating printed materials, including greeting cards and rack cards.  Monica- Jessica Plumb of Plumb Productions is creating videos for the Olympia oyster and eelgrass protection/no-anchor zone projects, and possibly the rain garden project. It started as a 5-year initiative particularly focusing on maritime culture in partnership with the Northwest Maritime Center. The program is implemented for all ages, and has drawn high quality teachers to the district. No other public school district uses a place-based model, particularly not maritime-focused. Successful projects have community partners, robust education value, a place-based learning theme, a positive impact on the community, and a public presentation by students.  Community partnerships typically develop organically. There are		
	over 70 partnerships in Jefferson County, and the Jefferson County MRC has partnered through the PT School District's 2-day teacher training in the summer. These are opportunities for		

	students to see real work and know what real jobs look like. Successful projects have invested teachers and community partners.		
	Examples of projects: artwork, creation of restoration planting plans and planting of trees, building bird boxes for nearshore bird habitat. Themes include stewardship, craftsmanship, cultural dimensions of community life, civic engagement, leadership, and economic possibilities and entrepreneurialism. This program includes the opportunity for career technical education and maritime academy classes and the opportunity to leave with certifications for vessel operations.		
	Several metrics suggest that the program is working to educate students and integrate the schools in the local community.  For more information: <a href="https://www.ptschools.org/curriculum">www.ptschools.org/curriculum</a>		
	What does place based learning look like remotely? It's been fully integrated in the curriculum, so it's not "going away" if classes need to go remote this year. Place-based learning doesn't need to be outdoor learning, so it could involve online research. Students are interested in continuing these projects because they can be more engaging than basic online learning.		
Bocc REPORT	Commissioner Brotherton – Shoreline Master Program update continues. The county received 11 applicants for the task force, including some MRC members. Commissioner Brotherton will let us know when meetings are coming up.		
	Coronavirus update: our neighbors are not doing great and social gatherings are the major problem. Jefferson County is doing well and will apply for Phase 3 again when there is an opportunity to move forward with opening.		
	The final EIS for the Duckabush estuary project is available.		
	The Environmental Public Health Dept. is doing a project on the Dosewallips to build resiliency with residents and ecology in the floodplain. There will be a second meeting for the powerlines reach project this Friday at 10am.		
	The Blackpoint forestry application is on hold for now.		
Port of PT UPDATES	Commissioner Petranek- Navy Right of Entry for Mats Mats The Navy has asked for a 5 year right of entry for military training exercises in Mats Mats Bay. They have also requested the same access at 5 state parks including Fort Flagler and Mystery Bay. Washington State has a public comment process for this. The Mats Mats access has been approved by Port Commission for 5 years with three 5 year extensions.  A constituent reported that the application is for military training exercises, at any time, with up to 20 personnel, simulated		
	weapons, etc. Commissioner Petranek expressed concern that there's not a coordinated approach to talk about Navy activity, because they have been approaching different agencies separately for separate activities.		
	Neil noted that the MRC wrote a letter within the last year to comment on the Navy's EIS. The options available in the EIS were to have the Navy increase activity or leave altogether. This activity is probably less concerning as an environmental impact, but more of an incompatible land use.	Find the final version of the MRC's comment letter on the Navy EIS, send to Pam. 	Solenne Walker suggested that because the tidelands are privately owned, the Navy may need permission from individual landowners. Question of whether this specific use is compatible with typical interpretation of Navigable Waters.		
	Point Hudson Jetty Permitting for the jetty is ongoing, and funding is being sought. The Jamestown S'Klallam Tribe is proposing to have a Floating Upweller System (FLUPSY) at Point Hudson where the kayak dock is currently. They are also asking to have a restaurant, bar, and seafood outlet.		

	Gordon noted that FLUPSYs can't be permitted in Port Townsend under the current Shoreline Master Plan. Taylor shellfish objected to this clause in the latest update.		
	Quilcene Coast Seafoods is seeking to buy port property. Commissioner Pam & Executive Director Eron Berg are meeting with a handful of community members to create an engagement process. Commissioner Pam invites feedback and will keep us updated.	Send comments on these topics to Pam	Everyone
	Commissioner Brotherton has suggested a subarea plan that creates a vision for that region, because the current zoning is not ideal. He suggests creating a 20-year vision, with some zoning for recreation.

	The budget amendment has been approved and we are good for a second year of funding through September 2021.

	Other MRCs are now interested in starting eelgrass protection projects. Kudos to those from Jefferson County who have presented on our eelgrass restoration program to spark this interest.		
Current and Upcoming Projects	Forage Fish (Jeff) – The survey team is using a tablet based form, with an app that sends results directly to Washington Dept of Fish and Wildlife (WDFW), which is working well. Jeff sampled last month and will sample again tomorrow. The app will be used by sites that are within the WDFW network.		
	There is a new site at Sarah's house as of June. They will continue to sample monthly.		
	<b>Kelp Monitoring</b> (Emily) – The kelp team has completed June and July surveys. In July, Tyler Cowdrey, a Master's student from Evergreen (formerly also DNR) joined the team to do a drone survey while the kayakers paddled. The drone images will be georeferenced and compared with the perimeter created by the kayakers. Tyler is planning to join the survey again in August. Emily became one with the kelp.		
	<b>No Anchor Zones</b> (Troy) – The Port Townsend buoys look fine. Troy will know more next month.		
	<b>Rain Gardens</b> (Bob) – We are set to do a second rain garden this year, with the City of Port Townsend, and will be installing plants September $24^{\text{th}}$ .		
	<b>Oly Oysters</b> (Neil) – Shell was delivered to Discovery Bay on June 22 <sup>nd</sup> . On June 23 <sup>rd</sup> , they dumped bags in the lagoon and right at the exit inside the spit. On June 25 <sup>th</sup> , MRC volunteers raked out the loose shell at the Powerline site, which probably was easier than spreading from bags. Members monitored on August 2 <sup>nd</sup> and Neil observed new set on the shell put out in June. Oysters are looking good and some have naturally spread south of the official restoration area. A small group also went to Brenda's house at Mystery Bay and found lots of Olympias on the beach.		
	Betsy noted there have been high levels of <i>Alexandrium spp.</i> (a biotoxin) in Mystery Bay. Results from the citizen monitoring program SoundToxins are sent to the Dept. of Health when there are high levels of these toxins.		
	Gordon asked about Mussel Watch results from 2017/18. We have the raw data from our sites, but WDFW has not released a report.		

	Education and Outreach (Brenda) – Shared some of the outreach materials that have been developed. The committee updated an eelgrass and Olympia oyster note card, and rack cards for soft shorelines and rain gardens. Betsy and Brent Vadopalas designed a large roll up poster. The committee purchased two inverted microscopes and one monitor to use at outreach events and hired Cheryl Lowe to update the website. The videographer hired to create project videos is expected to send a draft oyster video this week. Monica is looking for the North Olympic Salmon Coalition to donate drone footage from Discovery Bay, and we purchased some underwater video from Florian Graner.		
	Crabber Outreach (Roy) – This year's crab presentation was live-streamed. It was well received, with around 100 attendees (200 registered). The committee posted posters and distributed rack cards around town, which were welcomed by retail outlets. It was more difficult to post at state parks where offices are closed. Crabbing and fishing have been popular activities this year. Record counts at every beach for clamming. Shrimping was closed early. There are reports that crabbing isn't good in Port Townsend Bay this year.		
	In the future we should consider doing the crabber outreach presentation both online and in person.  Shoreline Landowner Outreach — N/A

PUBLIC COMMENT	None.		
	Betsy commented that the Port Townsend Marine Science Center will be opening on the weekends by reservation. Reservations can be made via the website.		
Q&A with BoCC Candidates Lorna Smith and	The BoCC candidates, Heidi Eisenhower (HE) and Lorna Smith (LS), each introduced themselves and their background knowledge and experience relating to marine issues.		
Heidi Eisenhour	The candidates were asked the following questions by MRC members:		
	How long have you been aware of the Jefferson MRC? What do you think the MRC does and what do you think the role of the MRC should be in Jefferson County?		
	HE- has been familiar with the MRC since the early 2000s, when she was working with the Northwest Maritime Center on dock placement near eelgrass habitat. The MRC is the marine advisory		

	body to Jefferson County and champions specific initiatives, such as rain gardens. LS- has been aware of the MRC for many years. She is excited about the eelgrass protection project and noted the importance of eelgrass and the threats it faces. She previously participated in a habitat analysis project on Jetty Island (Port of Everett) with focus on eelgrass beds and realized how important their nursery functions are.		
	What do you see as the most important issue to address related to marine resources or marine waters in Jefferson County?		
	LS- referenced a SeaDoc Society paper highlighting the issue of ocean acidification, requiring a regional and global effort to respond. She is also concerned about the resident orca population and would like to see the MRC work on protecting the orcas.		
	HE- noted the impact of climate change on storm events in the area, and how to respond as a community to these issues as they come up. She is also very concerned about the amount of plastic pollution in the water.		
	The Port of Port Townsend is attentive in its role as caretaker of many public properties and surrounding water. What kinds of experience can you bring to work alongside the Port?		
	LS- oversaw public works projects in Snohomish County for compliance with water quality standards. This experience with compliance is important for an entity like the Port. HE- has more upland experience, particularly issues with farmland water rights.		
	Jefferson County has a no net loss plan, but there's quite a bit of development on beaches. Many projects are unpermitted, but even permitted projects cause damage. Some people are being punished for doing things properly while others are rewarded for not going through the proper permitting processes.		
	HE- knows from her experience at DNR that there's only a certain amount of enforceability. She is unsure of what level of enforceability the county has but commented that the process for getting permits needs to be easier. There's a program in Kitsap to track the progress real-time. Jefferson County should shift to a customer service focus so that the process is easier and can offer technical service along the way.  LS- discussed environmental mitigation as a compromise and noted that in-kind, in-place mitigation is the only kind that works.		
	The Dept. of Environmental Health received a grant to provide cost-share repairs for failing septic systems in Hood Canal/Discovery Bay areas, but they're having trouble finding homeowners who qualify. How would you work on this?		
	HE- hears about similar issues frequently. Cost of septic repair is a huge issue in terms of developing affordable housing. She suggested reaching out through OlyCAP or a service provider who is working with the Jefferson Community Foundation to find homeowners that need help.  LS- The county needs better outreach. Lack of interest in the program could be because cost sharing is still beyond the reach of people living on the edge. She suggested tailoring the program to add additional help so that it's zero cost for property owners. She added that there needs to be a sense of community stewardship and that we're in this together.		
BoCC REPORT	Commissioner Brotherton – Pleasant Harbor Black Point Resort update: They have not submitted a forest practice application or removed stumps. Work has primarily focused on re-establishing survey lines and the project is moving forward.		
	The project to replace the boat ramp at Point Whitney is moving ahead.		
	The county has a grant to match costs for upgrading on-site septic systems. They are struggling to get enough landowners to use the grant. He requested MRC members to promote the project. There may be up to 100% cost share if the owner of the property qualifies based on income.	Email MRC members the flier advertising the on-site septic cost share program.  Promote the program. 	The COVID-19 situation is largely the same. It's concerning that		
	surrounding counties have higher numbers of cases. A major concern is getting schools safely started again.		
Port of PT UPDATES	Commissioner Petranek- Update on Point Hudson: The Shoreline Master Plan (SMP) revision process is going on right now. It would be helpful to get an update on the process from an MRC member. The Port is looking at working with Jamestown S'Klallam Tribe, who will be making a presentation on Sept 23 <sup>rd</sup> at 5:30PM. They will present about plans to install a FLUPSY (Floating Upweller System) and start a restaurant/bar and seafood outlet. They are looking at leasing the Pygmy Boats building. In 1994 a Master Plan was developed to guide management of Point Hudson. That process involved two years of community input and the city working with consultants to give direction. 	Judy Surber offered help walking through the SMP update and connecting with staff at the City of PT regarding Point Hudson.		
	Jeff Taylor noted that the estimated cost of the Point Hudson jetty replacement project has increased. Commissioner Petranek explained that the original dollar amount was based on a vertical steel wall while the new estimate is based on a rubble mound design. The cost of permitting and in-water infrastructure has gone up, along with tariffs. Some funding will come from property taxes, but the Port also applied for a federal grant. The Port is looking into hiring a part time grant writer and lobbyist to go after more funding.		
	A Linger Longer Committee has formed to develop a process to engage the wider community about land use in Quilcene. Part of the discussion is identifying how the Port can help with economic development and public access. Pacific Seafoods would like to buy a portion or more of the Port property, and the Port must consider the economic and environmental impact. What could we do with this property? What businesses can be down there?		
	Sarah Fisken is interested in continuing conversations about Quilcene.		
	Greg suggested that the first step could be to develop a Subarea Plan, which would then inform potential re-zoning.

	Kelp Monitoring (Emily)- The kelp team completed their last official survey of the season. There may be an additional survey/training day in September to solidify skills, because Emily will be leaving the MRC before the next survey season.		
	No-Anchor Zones (Troy)- The Port Townsend buoys look straight; they're in excellent shape and nobody was anchored inside. The

	Port Hadlock buoys look good, even though one boat anchored at the far end and swung into the eelgrass. It swung past the shellfish beds, so it's not in a critical area but unsure of how to deal with that. Will visit Mystery Bay soon.  Rain Gardens (Bob)- Volunteers are maintaining the rain garden at Cape George, which was installed in June. The second one of the year will be on the corner of Clay and Benton. Scheduled with City crew to excavate on Sept. 9th, planting on the 24th. They have to limit the number of people doing installation work.  Anyone is welcome to join in, but have to be less than 65 years old and 5 people or less total. Folks are otherwise welcome to observe either day.		
	Olympia Oysters (Neil)- Went out to Sarah's place to look at Olympia oysters. Quite a number of them present, especially in the intertidal areas. He put out shells with dowels on them and will see how many Olympias set on those. Lots of pacific oysters and Olympias intermixed. Dabob closed last week for PSP (Paralytic Shellfish Poisoning). High levels at many places.		
	Education and Outreach (Brenda)- Since August, the subcommittee has met to discuss the MRC's role in potential collaborations with local artists. The team has decided to take a step back from any projects/collaborations at this time to discuss the MRC's education and outreach goals and best strategies to meet them. The committee is meeting mid-September to talk about what those priorities might be and will be consulting with the NWS Commission about constraints on how funding is spent with artist partners. Rain garden rack cards are about to be printed.		
	Outreach videos for eelgrass and Olympia Oysters are close to finished. Videos will be hosted on the NWS Commission's Vimeo page to better track statistics, and possibly the County's YouTube page.		
	There was some discussion about the new bridge between Indian and Marrowstone Islands. The group expressed interest in having a representative from the North Olympic Salmon Coalition present on project updates.		
	Shoreline Landowner Outreach (Sarah)- meeting with Lisa Kaufman and Melanie del Rosario with the NWS Foundation on September 2 <sup>nd</sup> to discuss organizing a webinar and the possibility of meeting with shoreline landowners for site visits, etc.

	Judy- SMP update: There was a meeting to kick off periodic review amendments. The periodic review is not the same as updates (which are community oriented), rather it's review required by the state to make sure the document stays current with changes at the state level. The City of PT plans to revise and make clarifications in the process, in particular looking at climate change revisions. Recently added the goal of integrating climate change into city plans. GUEST SPEAKER Ian Miller, of WA Sea Grant, presenting on sea level rise projections	Dr. Miller summarized how scientists determine sea level rise projections and why sea level rise matters. Mean water is an average of high and low tides, sea level rise is an increase in that mean level. One-foot of sea level rise means one-foot higher high tides and one-foot higher low tides, which results in impacts to shoreline infrastructure. Sea level rise is linked to climate change.  Increases in atmospheric carbon concentrations track increases in global average surface air temperature. Increased temperatures associated with climate change causes sea level rise due to ice melt and thermal expansion. Global sea surface temperature is, and has been, increasing and ice mass is being lost. Land-based ice mass loss will accelerate in the future. Methane is a greenhouse gas which contributes to increased global temperatures which in turn drives sea level rise.		
	Projecting sea level rise inevitably comes with uncertainty. There is a scientific basis, but it is still a matter of trying to see the future. Thermal expansion is relatively easy to predict; more uncertainty comes from trying to determine where heat distributes globally. Much more uncertainty comes from land based ice loss than thermal expansion. Land based ice is key here, not sea ice which changes annually.		
	It is important to observe localized sea level rise projections. For example, while Seattle is seeing increased sea level rise, Neah Bay is seeing reduced sea level rise, due to differences in land		

	movement. WA state has a set of projections available online, which use a probabilistic framework and allows managers to choose what projected sea levels to manage for. We might expect as much as one foot of sea level rise 10-15 years from now. Two feet of sea level rise is an important threshold which will cause significant issues very likely by the end of the century.  In response to a question about whether sea level rise projections include frequency of storms: no, projections do not incorporate storm activity. Additionally, storm surge is not a major concern within the Puget Sound.		
BOCC REPORT	Commissioner Brotherton – Attended a presentation from Long Live the Kings about the Hood Canal Bridge Assessment Project. The Assessment Team is proposing to add fillets at the bridge to streamline the shape of the structure to facilitate the passage of juvenile steelhead. The Assessment Team is not considering an immediate replacement of the bridge, but is considering intermittent bridge openers to allow fish to pass through. Closing the bridge to traffic will likely see some public pushback.		
	Two MRC members have joined the Task Force for the County SMP review process.		
	Question posed to Dr. Miller: Is the ordinary high water mark enough to plan for sea level rise? Or should sea level rise be directly called out in planning updates? Dr. Miller responded that if we hit the rates of change that are projected for sea level rise, there will be little time to adapt and that decisions to build within the 200 feet of coastal zone will be sunk costs.		
	Mooring buoys are good protection for the shoreline, as they prevent damage from anchoring. The county will be trying to push buoys out of conditional use permits to streamline shoreline permitting. The county is also working to memorialize code interpretation, making them more accessible to the public and mirroring them at appropriate points in the permitting process.		
	The Covid-19 situation is largely the same, no updates.		
Port of PT UPDATES	Commissioner Petranek- County Commissioner Kate Dean brought up the Stormwater Strategic Initiative's Toxics in Fish Implementation Strategy. There is a public comment period which is an opportunity to weigh in and potentially get funding for MRC projects. Commissioner Dean is wondering if the MRC would take on that topic for the county. 	All three Port of PT commissioners are looking for a planning process for Quilcene. They are not considering sale of any properties at this time.		
	The Port applied for a grant for partial funding of the Point Hudson jetty and received feedback that their application is being considered. The total projected cost for the project is \$14 million. 	The Jamestown S'Klallam Tribe made a presentation to the Port about their proposal to install a FLUPSY (Floating Upweller System) at Point Hudson. The proposed FLUPSY size is 20x80ft, and the Tribe is looking to put it at the head of the marina to grow pacific oysters. Judy Surber has pointed out that it is not currently permittable to grow non-native species in Point Hudson, but Gordon says this may change with the next revision of regulations. GUEST SPEAKER Judy Surber (City of PT SMP) & David Johnson (County SMP)	Judy – Shoreline Master Program (SMP) includes policies and regulations specific to shorelines. Only used for proposals within shoreline jurisdiction which is 200ft inland from ordinary high water mark (OHWM). Includes associated wetlands, freshwater lakes >20acres, and streams and rivers over a certain flow.		
	SMP must be consistent with Shoreline Management Act (SMA). Shoreline uses, public access and recreation, protection and restoration of the natural environment must be consistent with shoreline guidelines (in the Washington Administrative Code) and meet WA State Dept. of Ecology's approval. If there is a conflict with zoning, the SMP prevails. Critical Areas Ordinance is incorporated and must be consistent with flood damage prevention.		

Areas get shoreline designations, similar to zoning. Uses within a designation are based on the sensitivity of that designation.

Currently conducting an SMP periodic review. SMP updates must comply with SMA and Ecology rules as well as local plans. This is a good time to clarify or amend codes. The review process differs from a comprehensive update, which is a multi-year, intensive review process involving an advisory group.

The City of PT is working on incorporating considerations related to climate change impacts, including sea level rise policy. Revisions are also anticipated in the aquaculture section, as there have been changes at the state level. Development should be consistent with the City's Stormwater Management Plan.

The State Legislature made changes in the Restoration section. Native kelp, eelgrass, and native oysters now qualify for Shoreline Substantial Development Permit exemptions. They also added a way to ensure that regulations didn't shift upland when shoreline restoration projects change the OHWM so as not to disincentivize restoration projects. Ecology is recommending that the City's Restoration chapter be a standalone document so that revisions don't trigger an SMP amendment process. The Restoration chapter was last written around 2006-7 – chapter revisions lend itself as a potential MRC project.

The City is currently organizing meetings to review draft amendments. Will go through State Environmental Protection Act (SEPA) review then a joint 30-day hearing (which includes public comment). There will be many opportunities for public comment before final review by city council and Ecology. Survey for initial feedback closes November 23<sup>rd</sup>.

David – The Jefferson County process is very closely aligned with the City process. The County formed a Task Force because the BoCC passed a resolution in 2019 for regulatory reform. There are 2 main goals: streamline the permitting process and rewrite code in a way that's easier to understand. Wanted code to be more user friendly and eliminate some unnecessary processes.

The Task Force consists of 12 members - they have had 4 meetings and developed 6 different focus topics. Review focused on regulatory reform goals. Ecology informed Jefferson County that they issued more shoreline conditional use permits than any other county in the state. Most of these permits were for single family home expansions within the 30ft buffer. Plan to make these a shoreline exemption and keeping the conditional use permits for vertical expansion. Towards water expansion will require a variance unless over existing nonpermeable surfaces. Plan to make mooring buoys easier to permit. Considering new policy to adapt to sea level rise: first option for structures along shorelines is to retreat, if not feasible then the next option is to move structures up, and the third option is shoreline armoring to protect the structure (though not preferred). May eventually evolve into development regulations. Want to encourage marine trades and development. Talking about rezoning upland area in Ouilcene marina to allow marine trades. The Task Force requested more boat launches, but the Navy wants to restrict development in the Hood Canal for security reasons. The County doesn't have much control over boat launches.

The Task Force compiled a list of 10 action items that they're following through. Completing checklist for periodic review and comments from staff. Deadline of Nov 30<sup>th</sup> for draft SMP into Ecology for their review. The Dept of Community Development has SMP info on their website. The final deadline is June 30, 2021

#### Q&A:

Conditional use permits are generally for incompatible uses, which doesn't really fit with mooring buoy applications. By changing to a substantial use permit, the environmental review will be the same - applications will still go through the SEPA process. Not losing any environmental regulations.

In Port Ludlow they're working with Jim Johannessen (Coastal Geologic Services) on a soft shoreline armor project to protect the townhomes in the face of increasing storm surge and sea level rise.

CURRENT & UPCOMING PROJECTS	Forage Fish Monitoring (Jeff/Sarah) – Jeff sampled in Discovery Bay. Results are going to be slow because the lab was shut down due to COVID-19 restrictions. Sarah has sampled 4 times now at the Dabob Bay site. Planning to start monitoring Fort Townsend for a fifth year of post-restoration monitoring (November through February or March).		
	Sea Level Rise (Emily) – Spoke with Ian Miller to follow up on questions from his presentation at the last meeting. There is no state mandate or allocated funding to update sea level rise (SLR) projections, but they keep an eye on new data for evidence that compels an update. One publication almost triggered an update, but they waited for results to be replicated/vetted, and it didn't hold up over time (the 2017 NOAA projections did use these data which explains some differences in the projection ranges). Updates also create anxiety, and the bottom line is that communities should make their own determinations for what amount of SLR would begin to cause serious damage and plan for that. Any amount of SLR planning at all is great; planning for 2-3ft of SLR is outstanding.		
	The frequency of storms and the severity of storms is not necessarily increasing in the Puget Sound region. Climate change doesn't seem to impact wave height/storm surge levels in our region. El Nino will be occurring with higher frequency in the 21st century, but the highest water levels may not always be associated with El Nino cycles.		
	<b>No-Anchor Zones</b> (Troy) – Took out summer buoys, replaced with winter buoys. Pam did a great job driving the boat. Gordon and Bryan also did great work. Buoys are in the WSU storage.		
	Rain Gardens (Bob) – Was approached by the Quilcene school about putting a second rain garden there. Going to meet with facilities staff and a teacher, then meet with the subcommittee to decide if that's a good project to take on this year. A committed group of Master Gardener volunteers weeded, replanted and mulched the rain garden at Chetzemoka Park.		
	Olympia Oysters (Neil) – Would like to do more of a presentation in December. Storms may be moving oysters to the south. In the southern part in Discovery Bay near the Powerlines Site, densities are looking pretty good. Found very little Olympia Oyster set on the shell that was placed at the Lagoon Site in June, but will likely see more in the spring as they grow.		
	<b>Education and Outreach</b> (Brenda) – E&O subcommittee met on Oct 13 <sup>th</sup> . In preparation of the meeting, sent out a survey about what they think is most important for education and outreach. Climate change education in the community was priority. Plan to develop tools including a guide for educating ourselves, then how to reach out and communicate climate science to the broader community.		
	Shoreline Landowner Outreach (Sarah) – Lisa Kaufman (NWSF) is organizing a workshop, which has been postponed until at least January.

2020 Project Highlights & Proposed Actions	<b>Volunteer Hours (Monica)-</b> Overall MRC hours reported for grant year Oct 2019-Sept 2020 was 1457 hours, compared to 1614 hours reported the previous grant year. While meetings do		

take up a large portion of MRC time, nearly half of the total hours were dedicated to on-the-ground projects.		
Forage Fish Monitoring Fort Townsend State Park, Port Townsend Bay (Monica)- Original goal was 5 years of post-restoration monitoring at this site. This is the 6 <sup>th</sup> year monitoring for forage fish at that site (1 year prerestoration and will be the 5 <sup>th</sup> year post-restoration). The team will be working on a summary of the project's results following the monitoring season (i.e. after March). Sand lance and surf smelt eggs have been found post-restoration. The site volunteers showed interest in continuing to monitor, though there was some discussion about the value of annual monitoring vs. monitoring the 7 <sup>th</sup> and 10 <sup>th</sup> years following the restoration work. If continuing to monitor annually, there was a suggestion to switch this to a long-term index site, which would use a slightly different protocol.		
Adelma Beach, Discovery Bay (Jeff)- Jeff and Cindy have been the only volunteers to monitor this site following the Stay Home orders. Lab analysis has not yet been completed due to delays related with the COVID-19 pandemic. Planning to continue monitoring at this site.		
Siri's Cove, Dabob Bay (Sarah)- This is a new index site, added as of June 2020. Completed 5 surveys at this site so far. The samples haven't been delivered to WDFW yet, so there are no results at this time. New volunteers are welcome and monitoring will continue in the future.		
<b>Kelp</b> (Emily)- The team completed 3 official surveys this year, some of which were in tandem with aerial drone surveys. Since Emily will be leaving the MRC, a new project lead is needed. Betsy is interested in continuing kelp, possibly taking on the lead role. Solenne and Bryan also expressed interest in continuing and being kept involved in any equipment trainings. The MRC acquired a YSI which will be used to take water quality measurements during future surveys.	Re-send link to aerial footage	Emily
Rain Gardens (Bob)- There were successful virtual trainings and 2 new rain gardens installed in 2020. The MRC has been involved in installation of 9,116 sq ft of rain garden since 2014. Going forward, looking to install 1-2 rain gardens per year, continuing maintenance, and training. Recently, Quilcene School reached out about adding a second rain garden on the other side of their parking lot. They have some funding to contribute and there will be donated excavator time/services.		
No-Anchor Zones (Troy)- This year saw ~98% boater compliance, a successful swap of buoys in the spring and fall, and a successful contract of diving services. Proposing to continue monitoring and servicing, adopt a diving manual and safety procedures, as well as reach out to partners and advise other MRCs. Gordon will reach out to Hama Hama contacts to see if they are interested in helping maintain the Port Hadlock shellfish bed buoys. Bryan has heard that Hama Hama might be looking to expand the shellfish beds in the future, and might want the buoys moved back. The buoys are augered in and easy to move, but would need approval/documentation if/when that occurs from DNR, Army Corps, Coast Guard, WDFW, and the	Communicate with Hama Hama about potential partnership to maintain the Port Hadlock buoys	Gordon

<b>Education and Outreach</b> (Brenda)- The education and outreach committee successfully spent down funds that would otherwise have expired. Funds were used to buy/update/improve ads, videos, rack cards, educational greeting cards, presentations, microscope, poster, and website updates. The committee prioritized needs based on what was outdated or otherwise nonexistent. Coming up, there will be a speaker series, a focus on climate change education, and an effort to reach a broader audience across the county, and possibly work with teachers and kids. <b>Olympia Oysters</b> (Neil)- Discovery Bay oly oyster restoration has done well and is enhancing a native population. This year, the team added clean cultch and monitored at the Powerlines		

	site. There were also reconnaissance site visits in Mystery Bay and Dabob Bay, and nice populations were found at both sites. Propose to continue spreading cultch and monitoring, and to look for new sites. May be reaching the permit limit for spreading cultch. Will begin taking water quality measurements with the new YSI, particularly at the Lagoon site. Will work on determining if and how we can monitor the population south of the restoration site for a better understanding of the Discovery Bay population, as cultch and settled oysters tend to drift here.  There are several factors which may be related to the lack of Olympia oyster success at the north end of Quilcene Bay, including presence of oyster drills and general heat stress. Some individual mortalities don't have a mark from oyster drills on their shells and some have dead vegetation on them. Southern Quilcene Bay might have more Olympia oysters.  Crabber Outreach (Monica/Sarah)- The MRC worked with the

2021-2023 New Project Ideas	Oil Spills (Jeff)- Interested in forming an oil spill working group to see what we might take on regarding this topic. Other MRCs have been involved in response plans and risk assessments. WA state Dept. of Ecology welcomes input, and some other counties are more active in providing input than we are. There may be resources to help us do so. The regional oil spill response plan is updated frequently, and there are calls for comments. We may have some concerns/input about what habitats are prioritized in response plans.		
	We took a poll, and Jeff was recognized as the de-facto project lead, though he welcomed others to step up if interested. Three votes indicated interest in volunteering on this project and four indicated potential interest with more information/discussion.		
	<b>Derelict Gear</b> ROV/Collab with teacher- Jeff discussed the potential for collaboration with a high school robotics teacher, using an ROV to survey for derelict gear. Possibly of use in marinas where side scanning sonar isn't feasible.		
	Shine Tidelands nylon rope removal- previously suggested by Roy. Not a whole project, but a one-time event that would fit under the umbrella of derelict gear.		
	Derelict boats- general topic that was discussed but without specifics. Generally noted that it is broad and complicated and would likely be its own separate project if taken on.		
	MyCoast app- discussion of use and potential for community training events. Would reach beyond derelict gear, since the app is also used for reporting large marine debris, king tides, etc.		
	We took a poll for a project focused on derelict gear. Two votes indicated interest in volunteering on this project and six indicated potential interest with more information/discussion.		
	Other Ideas?  Judy- There used to be training available for shoreline planners/ interested parties to learn about, e.g., native vegetation plantings for bluff stabilization. Something like this may be related to the MRC's shoreline landowner outreach efforts. Bob and others mentioned similar trainings that are still available. An idea was shared to offer MyCoast training at shoreline landowner and planner workshops.		

	Since Fort Townsend State Park restoration is complete- is there another park project we could partner on for restoration with State Parks, County Parks, or others?  Pam suggested looking into the ecological changes and potential needs at Quilcene Bay. Bob inquired if there was an opportunity to restore eelgrass in Quilcene Bay or other sites. Nam commented that DNR did eelgrass test plantings which included sites in Quilcene/Dabob Bays.  Emily- The speaker series is a good idea for Education and Outreach because there is always lots of interest in speakers. That being said, there are lots of speaker series in the region, between NOAA NWFSC, UW, PTMSC, WA Sea Grant, and others. It would be great if the MRC or NWSC could host a calendar or other repository of Zoom links where everyone could see what's available and access content.  Mussel Watch- mixed feedback on whether to continue this project. There is a long lag between data collection and reporting by WDFW so there is a question of what value these data bring.  Revise the City of PT Shoreline Master Program restoration chapter- Neil could provide revisions but is not committing to lead. Judy said that this chapter is mostly used for mitigation opportunities but not as often for straight restoration project may be good for Olympia oyster restoration. Potential to start investigating this as a restoration site.
