CALL TO ORDER GUEST INTRODUCTIONS	Chair Neil Harrington called the meeting to order at 6:00 PM. Introductions were made.	A quorum was present.	All members – please send volunteer hours to Monica

PUBLIC COMMENT	None.		
Guest Speaker: Kevin Long, NOSC Kilisut Harbor Restoration Update	NOSC (North Olympic Salmon Coalition) worked on the development of this project for 9 years. Excavation of the channel between Indian and Marrowstone Islands was completed in August of 2020. Construction took place over 15 months, and the bridge and roadway were completed around Nov 1st. The total cost for construction was \$10 million, which consisted of \$8 million for the bridge, while the rest was spent on channel restoration. An additional \$3 million was spent on the project design.		
	Historically, water flowed between Indian and Marrowstone Islands. Settlers would sometimes fill the channel to move cattle between the islands, but those fills were breached by Tribal members who continued to use the navigable waterway. In the 1940s, more fill was placed and the area turned into a major roadway with just two small culverts for water to pass. The surrounding marsh filled up with sediment because culverts were undersized. Restoring the waterway restores tidal flow and movement of juvenile salmon.		
	The Port Gamble S'Klallam Tribe has documented high numbers of juvenile salmon in Oak Bay, and high numbers of forage fish and other salmon foods in Kilisut Harbor. To reach feeding grounds in Kilisut Harbor, juvenile fish would have to swim		

	around to the channel at the north end of the islands. Post- restoration, the southern end has been opened, and fill removed, so that now a 450ft two lane bridge spans entire marsh.		
	AquaDams were used to keep the tide out. They are essentially giant bags of water connected as a wall to keep out tides during construction. The AquaDam worked well, but few had any experience with them previously. Almost a mile of hose was needed to continue filling the bags as the tide receded. A special shout out was given to Enrique, the aqua dam delivery driver, who was a dark horse of aqua dam knowledge and guided that portion of the project.		
	Night work was challenging but necessary to move the project forward. The fill went to a gravel pit in Port Hadlock that needed to be filled anyway. Lots of local contractors worked on this project. Many partners came together to fund the project and generate community support. It was challenging to fund this project because multiple extensions were needed for grant funds that would otherwise have expired after 2 years. The project continued throughout the Covid-19 pandemic.		
	Community members showed up as soon as the channel excavation finished to recreate in the area. Black bear tracks were found on the site. Lots of bird activity. There was a persistent red algae bloom for more than a month before the final channel excavation. The channel opening should help with persistent algae blooms and fish kills. Schools of surf smelt and sand lance have frequently been observed feeding in the channel. Cutthroat and dogfish have been seen, as well as adult salmon. The area is still changing and it will be interesting to see how the area evolves.		
	NOSC doesn't have forage fish spawning monitoring plans right now. Current monitoring includes beach profiling, drone flight with LIDAR, eelgrass monitoring on the Oak Bay side (though so far, there are no concern of impacts), and bird surveys. The Port Gamble S'Klallam Tribe has been fish seining and monitoring the temperature. So far the new channel doesn't seem to be affecting the speed of the current through the PT Canal.		
BoCC REPORT	Commissioner Eisenhour – Recently sworn in on the BoCC and has been assigned to the MRC. The BoCC is looking into developing workshops to discuss issues and include community members in conversations. We are very pleased to welcome Commissioner Eisenhour to the Jefferson MRC.		
Naval Special Operations Training Proposal	Neil- Introduced Larry Morrell, who has experience working on naval issues, and has been working on this topic for the last 2 years. He serves as an unofficial liaison between the public and State Parks staff regarding naval use of parks.		
	Larry- There is a proposal to train Special Forces (Navy Seals) on State Park properties. This involves insertion/extraction of submersibles, diver/swimmers, over the beach movement, special reconnaissance, and high angle climbing (the last one at Deception Pass only). They are asking to increase presence in 28 State Parks, with upwards of 36 training events (each ranging between 2-72 hours) in Region 1 per year (Jan-Nov) and up to 34 personnel involved per training event (including trainees, support and safety personnel).		
	They have been conducting this training over the last 5 years with a Right of Entry granted by State Parks (now-expired) in 5 parks, including Fort Flagler and Mystery Bay.		
	The Mitigated Determination of Non-significance (MDNS) is an agreement for mitigating measures including no surveillance of the public, reporting of artifacts, etc. But there is no provision for monitoring the impact of these activities. Unaddressed issues: State Parks is not listed under the last agreement, no notification to local law enforcement when training is underway, there is no follow up, no civilian monitors are allowed, there is no pretraining and clearance to proceed, and no provision to modify boundaries based on changing sensitive habitats.	Neil moved to approve the	
	Jefferson County is located within Region 1, which the Navy plans to use much more frequently than Regions 2 & 3. There is little evidence of consideration for bird or fish breeding seasons except in one specific case on the coast.	proposed special meeting. Seconded by Brenda. Motion passed.

CALL TO ORDER GUEST INTRODUCTIONS	Chair Neil Harrington called the meeting to order at 6:01 PM.	A quorum was present.	
Naval Special Operations Training Proposal- Share questions/ Concerns	Our aim is to provide recommendations to the Board of County Commissioners (BoCC) who will then communicate concerns to the State Parks. Individuals can also give input directly to the State Parks. There was consensus that we will restrict our recommendations to marine resources, rather than broader community concerns.  Solenne- Their proposal contains comparisons to general public		
	impacts on upland environments, but the general public doesn't enter the parks via submersible. Little evidence of consideration for impacts to the nearshore, especially eelgrass and kelp. There is a great need to focus on the nearshore environment. Eelgrass and kelp are critical for ESA-listed salmon and Southern Resident Killer Whales. We need to identify critical areas and possible exclusion zones. The proposed usage could potentially add up to significant impacts on critical habitat, and we should draw their attention to this so they can minimize impacts.		
	The proposal states that they will stay off of feeder bluffs.  Neil- The plan contains no mention of disturbance to eelgrass.		
	You can tear up eelgrass with a simple boat prop.  The proposal primarily focuses on impacts to terrestrial plants, not submerged aquatic vegetation (SAV).		
	Gordon- We don't know whether their submersible creates more damage than recreational/commercial digs or general uses.		
	Bob- has seen their submersibles, and they seem more intrusive than a small boat. The Navy should consider forage fish spawning habitats as well.		
	Neil- Ideally the Navy would complete the assessment of critical habitat and delineate exclusion zones. They could also consider restricting timing of trainings in certain areas based on critical life history stages for species of concern. People dig clams at night at Shine State Park. Navy needs to consult on tribal digs as well.		
	The Navy is not proposing to construct anything; the proposal is to conduct their training and leave no trace or impacts. There is a vague reference to training aids that are not supposed to have impacts.		

Brenda- hasn't seen any use at Mystery Bay or Fort Flagler State Park over the last 5 years, so if they have been using those properties then they have been very surreptitious.

Neil- understands that there does not seem to be any record of compliance. If they follow the proposal, impacts should be minimal, but there are concerns that there is very little record of compliance in years past. Perhaps State Parks should seek better proof of compliance.

Jeff- raised a concern about migratory birds.

Solenne- noted that since they are asking to use 28 state parks, impacts are spread out between sites, however while land impacts will be compared to regular uses, it's hard to know what the marine impacts will be.

The proposal states that they will avoid bald eagle nests. Training can be conducted anytime, day or night, between Jan-Nov. They typically infiltrate parks at night, hide unseen during the day, then exfiltrate at night.

Heidi- has not seen an increase in communication or collaboration since the 2018 BoCC letter requesting it.

Larry- The Navy has a history of not incorporating the feedback of other stakeholders, and doing what they want to do anyway. They are very nonspecific about locations, timing, and duration of the trainings, which makes it difficult to forecast the impacts of their activities. They don't have a requirement to seek outside consultation prior to a training event. State Parks said they don't have authority to grant Right of Entry to the Navy and instead passed it over to the Parks Commission, to seek permission to engage with the Navy. January 28<sup>th</sup> will be begin the process for Parks to conduct individual assessments, depending on instruction from the Parks Commission.

Solenne- The MRC should be specific in our recommendations, such as excluding the North Beach kelp bed from training activities, and other specific habitats in Jefferson County that we already know are critical.

Pam- suggested a more broad brush approach so we don't miss any critical areas.

Neil- proposed asking Parks to come to us when assessing the Navy's plan.

Bill Putney- urged the MRC to make clear and submit any specific issues that we identify. Specify the issues, reasons why, and limitations; don't assume the Navy already knows what we're concerned about.

Bob- We don't have the resources/information to identify all the areas where, e.g., forage fish are spawning, so language needs to make clear that they need to lead an assessment of impacts to these species.

Frank- suggested attaching a GIS map that delineates eelgrass/kelp beds to our recommendations to the BoCC.

Solenne- mentioned maps hosted by DNR, NWSI, and others. Our goal should be to raise awareness for the tools and what they [the Navy] should look out for.

Neil- eelgrass by the PTMSC would be a prime candidate for disturbance by submersibles.

Primary concerns listed so far: eelgrass and kelp beds (forage fish habitat).

Bill- The MRC should use this as a teachable moment for the Navy and the Parks. The committee should provide a one page letter with specific concerns, with sources of information, and recommended resources. We don't want the Navy to come back and say "you should have told us" if we don't alert them to our concerns now.

Larry- While the Navy has experts on staff, there is little evidence of them consulting with local experts. Suggestion to establish a

	liaison with the Navy prior to training to establish a relationship and flow of communication.		
	Troy- suggested we specifically state that we're doing kelp studies, studies on Olympia oysters, etc. and provide a map(s) of known resources. Others mentioned the Old Fort Townsend monitoring site and other forage fish monitoring sites as well.		
	Jeff- raised the idea that maybe they are specifically looking to train in kelp.		
	Brent- agreed that SAV, forage fish, and Olympia oyster are top concerns.		
	We have a seat for the Navy on the MRC. Bill Kalina used to fill this position, but his scope is specific to Indian Island and he is not part of this SEPA review process. Question of whether we should reach out to the Navy and offer consultancy, to help them identify and minimize impacts.		
	Pam- noted that we need for more communication from the Navy. Their proposal states that their staff will assess whether to continue an exercise if members of the public are present, which could include MRC members or others who are carrying out research or monitoring activities.		
	Heidi- It's appropriate to say that many of us are active on the water and concerned about our safety and the safety of our colleagues.		
Discuss line-by- line	Monica shared her screen and the group discussed edits/additions to the drafted outline for a recommendation letter to the BoCC.		
	Added endangered marbled murrelets to the list of marine birds to be considered.		
	Solenne- added links for SalmonScape and the forage fish spawning map as resources to provide.		
	Suggestion to leave a Navy liaison position up to the BoCC to designate. There were suggestions that this be an elected official for general ongoing communications, and suggestions to have an expert environmental science liaison.		
	Suggestion to add bird nesting sites and river otter habitat into list of considerations, however, others noted the need to focus in on important threatened and endangered species. River otters are abundant and resilient.		
	Pam- added a note about potential disturbance to ongoing research/ monitoring efforts		
Agree on recommendation to BoCC regarding potential impacts	After some discussion about the timeline required to get recommendations to the BoCC and be adequately considered, the group agreed upon an outline of recommendations and decided that a smaller subcommittee would complete final wordsmithing to forward a letter to the BoCC without need for further approval.		
	This was enough of a working session to feel confident sending this letter to the BoCC by the end of the next workday, as long as the smaller group only makes minor edits to wordsmith but not to change the letter's content.		
	Motion for a small subcommittee to make the recommendations more concise, but keep main points and content, and forward it to BoCC tomorrow. Pam moved to approve and Sarah seconded. Motion passed.	Pam moved to approve sending the draft letter to the BoCC after final editing/wordsmithing by a small group. Sarah seconded. Motion passed.	
	The current proposed Right of Entry will expire in 5 years, which is the maximum amount of time they can be granted approval. We could recommend review at shorter intervals. Reminder that anyone can comment as an individual.

Guest Speaker: Scott Brewer and Haley Harguth, Hood Canal Coordinating Council (HCCC)	HCCC is a council of governments, structured as a non-profit organization. Members include: Jefferson Co., Kitsap Co., Mason Co., the Port Gamble S'Klallam Tribe, and the Skokomish Tribe. They conduct work in the Hood Canal region, which can sometimes extend out to Sequim, depending on the project.  HCCC has an Integrated Watershed Plan (IWP) for the region, which serves as a strategic framework to advance a shared vision for fully integrated ecosystem recovery. Includes goals,		
	pressures/stressors, indicators and strategies. Can be found at ourhoodcanal.org. A Hood Canal Ecosystem Report Card will also be released soon, and information about what goes into indicators can be found on the website.		
	The IWP is adaptively managed and includes salmon recovery information. They are working to revise salmon recovery logic models to reflect the status of Hood Canal Summer Chum, and

	revising shellfish/nearshore logic model to integrate feedback from the Hood Canal Shellfish Initiative. Also developing intermediate performance objectives to track progress as well as expand communications and outreach.		
	The Pollution Identification and Correction Program is a collaborative partnership with HCCC members and partners. Fieldwork includes shoreline monitoring, pollution hotspot investigations, and site inspections with landowner support to correct pollution sources. Freshwater monitoring in priority streams. The program includes field training, outreach, and education.		
	The Hood Canal Shellfish Initiative is intended to function as a holistic approach to ecosystem recovery, focusing on shellfish. The HCCC brought together a workgroup of shellfish partners to identify content and priorities for an Action Plan. Participants developed a goal and 6 objectives to reach the goal. The HCCC has some funds to implement priority projects and is planning to integrate the shellfish plan in the IWP.		
	A Landscape Assessment and Prioritization Tool is being developed to prioritize projects, and a successful pilot was completed in early 2020. Awarded more funding to expand and further develop the tool.		
	Summer chum are in the home stretch of recovery; numbers are at the level where delisting is a possibility. HCCC is calling for an issues assessment to identify continuing challenges to salmon stocks. Salmon stocks have been linked with Pacific Decadal Oscillation, doing better in colder years and worse in warmer years for ocean temperature. They face challenges related to climate, climate change, and maintaining spatial diversity. A watershed use mapping tool can be helpful to understand what can or can't happen in summer chum critical habitat		
	Will be updating the Salmon Recovery Plan. Looking at multiple aspects like abundance, diversity, harvest management, climate change adaptation, with the goal of a "salmon recovered plan," meaning an ongoing strategy to keep them from declining again.		
	The HCCC also provides options for no net loss mitigation. \$4.3M of mitigation projects to date.		
	Land use tool is still in the pilot phase but a password is available by request. Could be useful to prioritize MRC projects.

Larry Morrell- Update on the Navy Operations Training Proposal	The Navy applied to train in 29 parks around the state. Our MRC had a huge impact on the parks staff report, and they even changed their Mitigated Determination of Non Significance (MDNS). Namely, eelgrass originally wasn't mentioned anywhere and fish windows/timing also weren't mentioned. The final MDNS is posted on the parks website. Staff and Parks Commission modified inputs. Determined that several parks would no longer be eligible (didn't name which ones) for several reasons. Port of PT UPDATES

GUEST SPEAKER Port of PT Update Point Hudson Jetty Project	<b>Mike Love</b> – Point Hudson Breakwater Improvement Project. One of the most important projects the Port of PT is working on, as it protects the port marina for 70+ boats. The last retrofit was in 1996, which required repair of the ends of the breakwater and some filling of rock. The most substantial rehabilitation work was in 1969, which included adding piling every 3 ft with walers. The original 1934 internal structure had creosote piles and rock-fill. Due to storms from the south that hammer the breakwater, the existing condition has timber piles, walers, cable tiebacks and rock armor deterioration and weathering; rocks break down and work through staggered piling; walers are also deteriorating and no longer extend to hold back the 1934 piling; and steel cable ties are fraying. Extensive storm damage in 2018 following high tides, extreme wind and waves prompted the Port to seek funding for repair.
	<u>Design Objectives</u> : Complete removal and replacement is the current plan based on engineering, aesthetics, environmental considerations, and constructability. The original design was the sheet pile wall, which opened bid, but there was not enough money and negative public feedback. Refocused on new objectives to last 30 years (typical), consider sea level rise, build it 3 ft taller with larger granite rocks and steel piling, reduce its footprint, protect eelgrass, minimize risks, and minimize costs, delays and overruns.
	<u>Alternate Evaluation</u> : Encapsulation vs. Replacement. With encapsulation, additional weathering of existing stone would be too detrimental overall. Complete replacement of both breakwaters is needed. The design for replacement will be similar in style to the existing breakwaters, with new materials and a walkway on the south breakwater.
	Breakwater Design: New battered, uncoated steel pipe piles closely spaced (3 ft on centers), to match existing aesthetics; additional tiebacks and walers on top of piles to support; and large high-quality riprap (granite) and walkway on top of the south jetty. Selected design is 3 ft taller with materials historically used. Permit drawings with cross-section shows new large armor stones as rock fill. Dredging will be required once the breakwater is complete to make sure the channel is navigable.
	<u>Funding</u> : Current sources include RCO, EDA Grant and Port Funding. RCO federal funds via a boat grant has been the source of money since 2016-2017 and requires NEPA review process.
	<u>Project Costs</u> : Construction \$13.6 million; Engineering, Permitting and Bid Docs \$400k, Construction South and North (\$500k); Grand Total = \$14.5 million.
	<u>Permitting:</u> Will include replacement of both breakwaters. Best case scenario is to have the existing permit modified for current design and completed within six months. Currently working through permit modification, first with federal grant, then local permits.
	<u>Environmental Considerations</u> : Creosote removal of 827 piles, smaller footprint, rock and debris removal, inwater work season (July–February), vibratory pile driver (vs. impact type), bubble curtain (mitigates noise from use of steel piles), floating debris boom, silt containment curtain, hours of work (7am-7pm), eelgrass avoidance and minimizing impacts to marina operation. Project will go on for months and be loud and noisy.
	<u>Timeline</u> : Project may take two construction seasons, starting with construction of the north breakwater. Earliest possible start date is August 2021, with completion of the north breakwater in March 2022. Will require five months of in-water work, if there are no delays: 5 weeks for demolition and 12.5-14 weeks for construction.
	Bryan asked for clarification of the meaning of "non-jurisdictional eelgrass." Eelgrass that is within the marina and potentially removed due to dredging to -12 ft elevation to ensure a navigable channel. Eelgrass mitigation may be required, onsite or offsite, still to be determined. Needs to be addressed.
	Jeff asked about debts and servicing debts. Project is currently fully funded, and the Port has a secured line of credit; a requirement of EDA funding is to show full capacity (50% from EDA as funding partner). Port is continuing to seek additional funding through the State legislature for an additional 7 million (IDD funds). Tax revenues are set from IDD each year, yet can be adjusted to what the Port needs, with ability to bridge gaps through loans while waiting for funding. There won't be additional costs to the community or additional user fees as a result of this project. Paying off with current tax rates.
	Judy highly recommended the Port to contact the City asap, to meet their current schedule. JARPA sent to Feds, but not local jurisdiction. August 2021 sets a tough timeline for the City to meet, with SEPA and flood development review needed due to FEMA audit. Mike Love said they just recently completed JARPA and will send to the City.

PUBLIC COMMENT	Barbara Moore-Lewis, representing the Brinnon Group- In 2018, the MRC sent a letter to the BoCC about the Pleasant Harbor Master Planned Resort (MPR) in Brinnon. The Brinnon Group shares the concerns expressed in the letter. The letter stated that the MPR should comply with the County approved water quality plan, with monitoring to be paid for by the developer and to include regular offsite and onsite monitoring. In the event of deterioration, the County should consult with the MPR, residents, and the Department of Fish and Wildlife (WDFW).  There's been extensive logging in the last year. The Brinnon Group wants to know what the County has approved for the water quality monitoring plan. There has been a history of lawsuits regarding this development.  Commissioner Eisenhour- will look into this and report back at next month's meeting. Will talk to the Developer, head of Department of Community Development, the Civil Deputy Prosecuting Attorney, and the Clean Water District Director.		
Guest Speaker: Dr. Filipe Alberto	Pacific Kelp Genetics- Why do we care about genetic diversity? It allows us to get a sense of past population history, current life history, and hints towards future evolvability and resilience. In		
	history, and hints towards future evolvability and resilience. In recent years, kelp has been in the news because of steep		

declines in California. Salish Sea populations are small and fragmented. Bull kelp range-wide genetic structure • Research questions about the extent of dispersal and response to previous glaciation/environmental conditions. • Samples collected at 50+ sites from Alaska to California. • Used microsatellites to look at areas in the genetic code prone to higher mutation rates. • Oregon & California populations were distinct from outer and inner Washington, which were distinct from Haida Gwaii and Alaska. Washington had less diversity than other regions. Suggests that bull kelp had two refugia (north and south) during the last glaciation. • Giant kelp increases in diversity towards Baja California. • Allelic richness decreases with distance from Tatoosh Island, towards inner Puget sound. Kelp rafts might matter for dispersal, but this happens over many generations. Seascape genetic analysis of differentiation in the Salish Sea · Associated the genetics analysis with ocean currents and environmental variation. • Simulated a spore release. • Considered isolation by distance, oceanographic transport, and environment (summer sea surface temperature, light penetration, chlorophyll a values). • Oceanic distance had the greatest association, more than spatial distance or environmental factors. Cannot point to causation, but association hints that something might be going on. Populations in the inner Salish Sea are isolated, with low genetic diversity. How to interpret this low genetic diversity? Need further studies to determine whether to preserve the inner Salish Sea populations in isolation, or to plan for genetic rescue from the Strait of Juan de Fuca. Planning to continue research (field transplants, temperature tolerances) and genomic analysis. Will look for inbreeding and mapping back to the genome. Looking ahead to breeding/conservation · Working on creating a seed bank of gametophytes to continue kelp genetic analysis. • Working with Puget Sound Restoration Fund. Have collected 1400 gametophytes which will be expanded in 2021 to cover more sites. • The future of kelp mariculture is promising, and there is currently no selection and improvement of traits, though selection requires genetic diversity and that is lacking in Puget Sound. Lingering question: If bull kelp in the inner Puget Sound is to be managed without genetic rescue, is there a future for aquaculture in the region? Crossing isolated populations, even within Puget sound may increase hybrid vigor. When population size decreases, usually genetic diversity decreases. But we don't know where the south Puget sound population started. No unique alleles were found in the Puget Sound population. BoCC REPORT Commissioner Eisenhour – The Olympic Coast National Marine Sanctuary is getting a new boat, currently deciding on its name. A great resource in our region for research. Commissioner Eisenhour sent a letter to Congressman Derek Kilmer in support of the Columbia Basin Plan to take out the Snake River Dams. This is the beginning of a conversation. Met with the Navy Seals and saw a demonstration of their training. Still pushing for information on the other locations where they plan to do training operations in Jefferson County. Received a letter in response that they would not be providing that information.

	Attended a presentation on the impact of growlers (Navy planes) on marine species. Study proved that the growler sound does break the water barrier and there may be ways to reduce impact of noise on marine species, such as increasing the elevation of growler flights.		
	The Devils Lake Natural Area Proposal, which is for land adjacent to Dabob Bay, will not receive funding this year. None of the Trust Land projects will be funded, as the program did not make it in the State capital budget.

PUBLIC COMMENT	Barbara Moore-Lewis, representing the Brinnon Group- In 2018, the MRC sent a letter to the BoCC about the Pleasant Harbor Master Planned Resort (MPR) in Brinnon. The Brinnon Group shares the concerns expressed in the letter. The letter stated that the MPR should comply with the County approved water quality plan, with monitoring to be paid for by the developer and to include regular offsite and onsite monitoring. In the event of deterioration, the County should consult with the MPR, residents, and the Department of Fish and Wildlife (WDFW).  There's been extensive logging in the last year. The Brinnon Group wants to know what the County has approved for the water quality monitoring plan. There has been a history of lawsuits regarding this development.  Commissioner Eisenhour- will look into this and report back at next month's meeting. Will talk to the Developer, head of Department of Community Development, the Civil Deputy Prosecuting Attorney, and the Clean Water District Director.		
Guest Speaker: Dr. Filipe Alberto	Pacific Kelp Genetics- Why do we care about genetic diversity? It allows us to get a sense of past population history, current life history, and hints towards future evolvability and resilience. In		
	history, and hints towards future evolvability and resilience. In recent years, kelp has been in the news because of steep		

declines in California. Salish Sea populations are small and fragmented. Bull kelp range-wide genetic structure • Research questions about the extent of dispersal and response to previous glaciation/environmental conditions. • Samples collected at 50+ sites from Alaska to California. • Used microsatellites to look at areas in the genetic code prone to higher mutation rates. • Oregon & California populations were distinct from outer and inner Washington, which were distinct from Haida Gwaii and Alaska. Washington had less diversity than other regions. Suggests that bull kelp had two refugia (north and south) during the last glaciation. • Giant kelp increases in diversity towards Baja California. • Allelic richness decreases with distance from Tatoosh Island, towards inner Puget sound. Kelp rafts might matter for dispersal, but this happens over many generations. Seascape genetic analysis of differentiation in the Salish Sea · Associated the genetics analysis with ocean currents and environmental variation. • Simulated a spore release. • Considered isolation by distance, oceanographic transport, and environment (summer sea surface temperature, light penetration, chlorophyll a values). • Oceanic distance had the greatest association, more than spatial distance or environmental factors. Cannot point to causation, but association hints that something might be going on. Populations in the inner Salish Sea are isolated, with low genetic diversity. How to interpret this low genetic diversity? Need further studies to determine whether to preserve the inner Salish Sea populations in isolation, or to plan for genetic rescue from the Strait of Juan de Fuca. Planning to continue research (field transplants, temperature tolerances) and genomic analysis. Will look for inbreeding and mapping back to the genome. Looking ahead to breeding/conservation · Working on creating a seed bank of gametophytes to continue kelp genetic analysis. • Working with Puget Sound Restoration Fund. Have collected 1400 gametophytes which will be expanded in 2021 to cover more sites. • The future of kelp mariculture is promising, and there is currently no selection and improvement of traits, though selection requires genetic diversity and that is lacking in Puget Sound. Lingering question: If bull kelp in the inner Puget Sound is to be managed without genetic rescue, is there a future for aquaculture in the region? Crossing isolated populations, even within Puget sound may increase hybrid vigor. When population size decreases, usually genetic diversity decreases. But we don't know where the south Puget sound population started. No unique alleles were found in the Puget Sound population. BoCC REPORT Commissioner Eisenhour – The Olympic Coast National Marine Sanctuary is getting a new boat, currently deciding on its name. A great resource in our region for research. Commissioner Eisenhour sent a letter to Congressman Derek Kilmer in support of the Columbia Basin Plan to take out the Snake River Dams. This is the beginning of a conversation. Met with the Navy Seals and saw a demonstration of their training. Still pushing for information on the other locations where they plan to do training operations in Jefferson County. Received a letter in response that they would not be providing that information.

	Attended a presentation on the impact of growlers (Navy planes) on marine species. Study proved that the growler sound does break the water barrier and there may be ways to reduce impact of noise on marine species, such as increasing the elevation of growler flights.

**Emilia** – on Bravo Team, Maritime Skills and Marine Science. Really fun to go out on the water in longboat and sail and row and do science projects. Used nissan bottles to sample water at various depths. Classes mostly held online due to covid. Environmental Service Project asked - How is climate change affecting the Salish Sea? How do we know the Salish Sea is healthy? Do humans have any positive effects on the Salish Sea? Learned through videos from WSU on how rain gardens work and how Puget Sound benefits from the rain gardens. They keep the ocean clean, add greenery, and support the earth and marine ecosystems.

**Chrissy** – helped teach 11 students on how to mitigate pollution and protect Puget Sound with rain gardens. Researched plants and plant functions to determine which plants should go into the rain garden. First hand dug sod to get rid of grass and rhizomes. Two truckloads to city recycling facility. Bioretention mix added with new soil by hand. Got lots of questions from passersby. Thurston County WSU extension delivered plants, set out all the plants and showed how to plant for best survival. Students really got into plants and took pride for improving the site. Students benefitted from being outside, working together and beautifying the earth.

**Bob Simmons** - Rain gardens are a great thing to do. Signs will be updated at NW Maritime Center. Put in more aesthetically appealing plants. Went out every two weeks and accomplished a lot. Main Street has gardener on staff to maintain this rain garden. Types of plants include: blue elk sage, coast strawberry, creeping raspberry, rosemary, sedges and rushes, rock rose, yarrow, oregon grape and sword ferns.

Other Rain Garden projects – Clay and Benton St rain garden looks great. Chetzemoka Park: has become overgrown with weeds, plants not surviving well, and in the third year stopped irrigating. Master Gardeners recently cleared out with help of the MRC, put in new plants and mulched. Quilcene School: second rain garden now drains half the parking lot. Local excavator donated time and school needed a storm drain and pipe installed. MRC provided funding, students did all the work and learned math and science. Most were high school with some younger groups helping out. Franklin and Adams Street is the next planned rain garden and just has to be approved by the City.

Question: What does science show on how rain gardens protect water quality vs. grassy swales? Rain garden plants are more deeply rooted and bioretention soils do most of the work. WSU researches best plants for rain gardens. PT Coop has stormwater issues on right (south) side of Coop, but not the best area for a rain garden, better for a permeable asphalt mix. Parts of Coop, Kah Tai and Port area are within floodplain.

Comment: Great to see these rain gardens refreshed! If there's capacity for tackling one more, the one downtown, next to the Hot Dog stand is looking sad. It is in a highly visible location and has the rain garden signage.

### **BoCC REPORT**

**Commissioner Heidi Eisenhour** – Dove into <u>Pleasant Harbor Development Agreement</u> - on county commissioner's website. Forest removal is now under FPA permit. One year ago they had not applied for FEIS and logged without a FPA (according to B. Moore-Lewis). FPA includes a new site plan. Water Quality plan in appendices. Don Holman conducting required groundwater monitoring every month. Port Gamble Tribe involved in water rights with Pleasant Harbor.

Port Hadlock - received 20 million in legislature. Meeting with every landowner for Port Hadlock sewer. Working with Peter Bahls on Trust land parcels to extend the boundary of the Dabob Bay natural protected area.

Strait ERN LIO is having nation-to-nation conversations with local Tribes about defining priorities.

Olympic Discovery Trail – received 4.6 million from the legislature; spans south around Discovery Bay from Milo Curry to Anderson Lake State Park, also completes a stretch in far west Clallam County. Clean Water District - testing septic systems and water quality monitoring to report on hot spots and what's happening in Chimacum Creek watershed every

spawning populations, and that we need to build natural spawning populations for salmon like chinook which are on the endangered species list. The movement of billions of eggs between river basins over the past 125 years (i.e., the timeframe there have been hatcheries) have moved millions of eggs out of rivers of origin into other basins. Essentially, every creek within driving distance from a hatchery received eggs, therefore when we cut hatchery production, we're getting less fish.

Russ Howell shared a presentation slide of an 8-year snapshot (1980-1987) showing in- vs. out-of-basin transfers. 277 million fish were transferred out of basin, or equivalent of 85% of all transfers were out of basin during these years. Of 40 facilities, 36 (90%) received fish from other basins. Of 27 river basins, only 1 (Snake River) did not receive fish from other basins. The result has been extensive genetic mixing for over 100 years. NOAA talks about "cleaning" hatchery fish out of spawning grounds, but 90% are hatchery fish, so all finfish are descendants of the last batch of hatchery fish. What we call a "wild fish" is in many cases one generation removed from the hatchery, in some cases 3-4 generations, others maybe 20.

Protection of wild fish as the primary driver of resource management policy is "wrongheaded" and has never resulted in a sustainable improvement in the production of salmon. What we have been doing hasn't been working. There is no genotypic, pure wild fish left. They contend that a properly managed hatchery program will allow hatchery fish to breed on spawning grounds with wild fish, making hatcheries the primary tributary in the river system. Why is it so difficult to operate the only lever we have in a timely manner, pending habitat restoration, which is essential but a decades long effort? In the meantime, we need to use the levers available at our disposal to preserve the genetic diversity mandated by the Endangered Species Act (ESA) and to increase the number of fish in the water.

Dave stated that 90% of Puget Sound chinook are now late run salmon. We used to have spring, summer and fall runs. The old Dept. of Fisheries tried to sustain commercial fisheries, yet was not looking at the big picture, jamming hatcheries into 4-6 week windows. Dungeness River was also a spring and summer run, then just a late summer run. These long term impacts have impacts on SRKW. Now chinook production is geared toward fall run fish only. Between 1989 and 2017, hatchery fish declined from 150 million to 80,000. The decline of SRKW parallels naturally declining fish in river basins.

What is a wild fish and what can we do to facilitate its recovery? Depends on the river basin, yet a segregated program can only use hatchery fish to return, an integrated program uses all the fish within the river basin. Strongly in favor of the integrated program. Wild-wild, hatchery-wild, hatchery-hatchery all becomes a wild fish, or a natural origin fish. Even tribes would like to see the state build its hatchery program back up to its 1980s level. NOAA and USFWS put tight restrictions on whether you can take a wild fish and put it in a hatchery system. Yet, we really don't have wild fish anymore, only a natural spawning population.

There was a question about what would make a well-run hatchery program. Dave responded: an integrated program with in-basin stock, and to look at run times and get the full spectrum on chinook – spring, summer and fall - by river basin. Moving between basins dilutes populations. We shouldn't be worried if hatchery fish are spawning with wild fish in an integrated basin. He believes a fully integrated program can get the chinook de-listed.

There was a comment that Kurt Beardslee from Wild Fish Conservancy had stated that all hatchery production and all fishing should stop to allow wild populations to rejuvenate. Dave responded that that only works in an ideal situation with habitat like Alaska, otherwise it would be 200-500 years for natural populations to recover that way. He reiterated that the hatchery should be considered the best tributary in the river basin. Tribes also depend on 50% of the fish from hatchery production. Russ responded that Beardslee is wrong on the facts, that salmon would go extinct since the pace of decline outpaces habitat restoration. If you took all fishing off the water and closed hatcheries, chinook would be gone in a decade.

There was a comment that hatcheries are a vital part of recovering chinook, yet hatcheries are not the only way to solve declines; it's up to habitat too. There was question of the statement that there has been more than 100 years of genetic mixing, being solely based on 8 years of transfer data, and encouragement to review genetic studies. Russ responded that

	this analysis was not only based on 8 years of data but extrapolated data to other years when billions of fish were being transferred to other river basins, when management was "willly nilly" and involved "johnny appleseed-ing" of fish. They used to dump fish into the Puget Sound from the back of ferries. Russ reiterated that the transfer of billions of fish translates to genetic mixing and therefore there is no such thing as a genetically pure stock of chinook. There is a certain level of genetics the stock needs to maintain according to NOAA, and we need to recognize genetic distinctions across river basins, attributed to stocks and adaptations, but what we're seeing is that fish can adapt to a particular river in a few generations. Integrated hatchery programs are the way to increase productivity and sustain genetic diversity.

	Surf Smelt: abundant, spawn intertidally year-round, smelt egg size: 2 mm and hard to see with the naked recreational fishery.		
	Sand Lance: common, less well-known, only spawn in smelt, live 7-9 years, no commercial fishery, unique in the day and burrowing in sand at night.		

See WDFW Forage Fish Spawning Habitat Map for forage fish habitat. Qualitative studies began in 1972-1990; 1991-1997, re-funded 2013 for presence/absence data for spawning periods to inform permits and work windows. Surf smelt and sand lance overlap in spawning Indian Island: 4 index sites primarily on Kilisut Harbor side - based on access, relatively undisturbed intertidal area, and high-level security. Beach 4, 6 and 9 are hot spots for sand lance. Use the "blue bowl" method: quadrat sampling frame to retrieve quantitative subsamples. Layout 200 ft tape above and below +5 to +8 tidal elevations, randomized sampling with half the substrate. Lab procedures are different from WDFW for their index sites: rinse, funnel with small mesh, rinse 5 minutes per sample, smelt eggs flow over, sand lance eggs are sticky and heavier so tend to stay and not flow out: 97% recovery rate smelt, 74% recovery rate sand lance. Samples <200 will count each egg and age class, if >200 eggs take 2 ml, three replicates and count eggs in maze chamber. One sample can have up to 16 larvae classifications. Identification: Surf Smelt have a "pedestal" attachment site. Sand Lance do not have "pedestal", smaller with sand grains around them. Size and egg yolk sac position are the easiest way to tell the difference between the two. Sample Year 1 = 2009-2010; Year 8 = 2017-2018. Samples had upwards of 900-1,000 eggs. Smelt have wider range of peak times, sand lance always peak in November (Ft Townsend November-December). Each beach sampled for 40 subsamples twice a month on new and full moons, spawning cue for both species. Water temp appears to be cue for sand lance, smelt more malleable about when to spawn. Sand lance show high variation between months and years, with no cyclical pattern between years. Some years you can dig for sand lance after spawning frenzy in upper beach. Fort Townsend: before and after bulkhead removed (Year 4 = 2014). PNPTC studied two years before restoration work in 2016, when there was less than one sand lance egg per sq ft. State classifies spawning beach as two or more eggs present per sq ft. Some eggs in 2017 (Year 7), but not consistent. Sites 2 and 3 are where the majority of eggs are found, on both sides of the restoration site. Higher abundance of smelt eggs in Year 5 ~2500 eggs collected. Current Project Updates and Subcommittees	Forage Fish Adelma, Fort Townsend, Dabob - (Sarah) - Jeff monitored Adelma on 10/4. Sarah monitored at Dabob a couple weeks ago and took samples to the WDFW office. Wednesday morning (10/6) will do first monitoring of the season at Fort Townsend.		
	<b>Kelp</b> (Monica)- Meeting coming up Oct. 15 <sup>th</sup> to reflect on the season and plan for the next one.		
	Rain Gardens (Monica)- Bob is on sabbatical until May, so there is one less rain garden installation planned this coming year. He is, however, working with separate funding to install one at the Dungeness River Nature Center on 10/7 & 8. He may need additional volunteers this week – reach out to Monica if interested. The subcommittee should meet to tour existing rain gardens and note what maintenance may be needed on those.		
	No Anchor Zones (Troy)- Hoping to swap the PT buoys with floats sometime in the next month. Current buoys look good, missing ones will need to be addressed. Gordon has winter floats at the hatchery. Gordon will be back in a few weeks, will need to coordinate getting them into town from the hatchery if the team is looking to switch them out before he gets back. Sarah volunteered to grab them. 	Neil- 12 European Green Crabs were recently caught around Jimmycomelately Estuary: 7 females, 5 males. All were the same size class and all looked very healthy. WDFW caught some on Indian Island this year, no other ones were caught. Those individuals were caught by hand in Kilisut Harbor, then WDFW trapped and didn't find any more. Thousands have been caught		

	in Lummi territory, and the Makah Tribe has been trapping for years without an appreciable decrease. Keeping green crabs out of the Salish Sea may not be possible at this point. GUEST SPEAKER- Seth Ballhorn, WDFW, Duckabush Estuary	<b>Seth Ballhorn - WDFW, Duckabush River Estuary Restoration.</b> WDFW partnered with Army Corps of Engineers (USACE) to share the costs of large-scale estuary restoration for the Duckabush, as a place of national significance. As state lead, WDFW is also partnered with WSDOT and HCSEG.		
Restoration and Anna Robinson – Hood Canal Salmon Enhancement Group (HCSEG)	The purpose of the restoration project is to improve water quality and habitat, reduce backwater flooding, modernize highway design and rebuild estuary resiliency. Approximately 75% of delta tidal wetlands in Puget Sound have been lost or degraded. Estuaries, where salt and fresh water meet, provide vital habitat, clean water, nutrients and protection for coastal flooding.		
	The original highway was built over the Duckabush Estuary in the 1930s with fill added nearly 12ft high. Two main river channels were confined and smaller channels completely blocked. A new wider and elevated bridge will be built by WSDOT to span the estuary. USACE will then remove old highway infrastructure and reconnect the four historic tidal channels. Culverts will be removed, channels re-established, large woody debris added. Herd of elk will now have access to the estuary. The new bridge will include 12ft lanes and 5ft shoulders across the bridge, and will be 6ft higher than the current bridge. Duckabush Rd will be re-aligned, a new left turn lane will be added, as well as a new parking area.		

Anna Robinson, Hood Canal Salmon Enhancement Group (HCSEG) - Estuary restoration addresses ESA-listed species Hood Canal Summer Chum and Mid-Hood Canal Chinook. Great habitat protection for juvenile salmon since estuaries buffer juvenile's life stage and physiologic transition between fresh and saltwater. Chum spend majority of life in estuary and are the first salmon to run in the fall. All adult chum spawn and die in lower river reaches which then benefit other juvenile salmon from nutrient enrichment. Mid-Hood Canal Chinook in Duckabush numbers are not very high (tens to hundreds); low like Dosewallips. Other salmon present include pink, coho and steelhead. Monitoring will focus on baseline of habitat conditions: sediment deposition, vegetation, water quality, and bird usage. No plans to do fish-use monitoring at this time. There will be citizen science opportunities for pre-project monitoring for baseline conditions. If interested in volunteering, contact HCSEG at www.pnwsalmoncenter.org Community volunteers in June 2020 removed nearly 2.500 lbs of debris and trash from estuary and wildlife area. Will be continuing with annual community cleanup efforts. Timeline: Working on construction funding. Design completed mid-late 2022, then takes about 3-4 years to complete. WDFW will cover 60% of the costs (about \$50 million from state capital budget), USACE will cover 40%. Exploring FEMA grant for more federal funding to address access and emergencies. Infrastructure bill will help provide funding, when it gets passed. Septic systems impacting the river are beyond the scope of the project, yet an improved estuary will increase filtration and improve water quality in tidelands. Shellfish habitat in outer estuary assessed in final Supplemental EIS, available on the WDFW website. Determined there would be short-term impacts, but not long-term impacts. Revegetation efforts will commence after construction. Need to be careful with mulch and timing of hydroseeding.    Determined increased number of surf smelt and sand lance eggs detected since 2016 nearshore restoration project.
- Adelma Beach 6<sup>th</sup> year monitoring.
- Dabob Bay almost 2 years monitoring, new sampling location proposed to the south.
- WDFW has capacity to analyze samples collected from more forage fish sites. NOSC recommended Kilisut Harbor, Irondale Beach, and Maynard. Janette recommended Fort Worden site below stairs, south of marine science pier. Heidi and Janette said they could get Irondale site photos for WDFW to consider.
- Forage Fish surveys are good projects for engaging community volunteers. Would just need an MRC member(s) to take on lead.
- o Upcoming WDFW forage fish survey training offered at Padilla Bay.

**Kelp** – 6<sup>th</sup> year monitoring bull kelp at North Beach.

Solenne – Seasonal monitoring of North Beach beds will continue based on protocol of surveying densest rockfish habitat. North Beach bed not a well-defined bed and fringes into patchy kelp. Photo-documentation of beds from bluffs or drones may help to establish whether this type of documentation can adapt well to citizen science. Drones may be too expensive and require license commitments, so may have to rely on volunteers with drones. A county-wide assessment of kelp beds via boats is planned to map all floating kelp beds. Seeking boating volunteers for next summer. Consider installation of a continuous temperature sensor buoy at North Beach yet depends on future funding. Plan to improve nearshore survey of kelp hugging shoreline, improve identification of understory kelp and other marine species, and support future kelp exhibit at new PT Marine Science Center.

**Rain Gardens** – Installed 2 new rain gardens: one at the Quilcene School parking lot (led by school staff) and one at the corner of Franklin and Adams Streets in Uptown Port Townsend. Need better recruitment of volunteers for rain gardens. Lots of maintenance needs on rain gardens. Janette will reach out to Master Gardeners and recent WSU class members with interest in rain gardens.

Voluntary No-Anchor Zones — Adopted a dive safety manual to ensure safe dive practices and adherence to state regulations. Troy attending "Salish Sea No-Anchor Zone" meetings with regional partners working on establishing voluntary no-anchor zones for eelgrass protection. Working on contracting video-tow eelgrass surveys along Port Townsend waterfront some time spring-summer 2022. Staff with the DNR Nearshore Habitat Program are willing to help with survey planning and video analysis. It was suggested that the survey include the same transects as in previous surveys, extending them to -15m relative to MLLW and slowing vessel speed for better quality video footage. Bryan asked what is the ultimate goal for data collection? Video-towing provides presence/absence of eelgrass distribution. Interested in determining density. Multi-beam not more definitive. Can differentiate Z. marina vs. Z. japonica both in morphology and location. Z. japonica typically found shallower above "zero" and uncommon in Jefferson County.

All – let Monica know if you are interested in taking lead on a new forage fish site(s).

All – let Solenne know if you have a boat to assist with county-wide kelp assessment during low tides summer 2022.

All – let Janette know if you can help with rain gardens. **Olympia Oyster Restoration** – Lagoon site – 5<sup>th</sup> year, Powerlines site – 7<sup>th</sup> year. Neil reports over 52,000 Olympia oysters on the plot with good recruitment. Working on permitting to expand the Powerlines site to include a new property lease located just adjacent and SW.

**Education and Outreach** – Published educational ads targeting boaters (eelgrass protection) and individuals (actions to improve water quality). Launched a new speaker series in partnership with the Port Townsend Marine Science Center, with a virtual presentation on microplastics/marine debris coupled with a beach clean-up event in September. Plan to develop the speaker series, offer hybrid "Digging for Dinner" and "Searching for Seaweed" (sustainable harvesting of edible seaweeds) events, and participate in the Wooden Boat Festival in the coming year.

**Crabber Outreach** – Promoted virtual workshop and distributed posters and rack cards, in partnership with the NW Straits Foundation.

**Shoreline Landowner Outreach** – Helped organize >21 site visits in East Jefferson County in partnership with the NW Straits Shore Friendly program. Promoted virtual workshop.

**New Project: ROV/Mapping Lost Crab Pots** – Discovery Bay ROV trial run in July with the SeaDragons and Ross Anderson, who lent his boat. Working on contract for side scan sonar survey in 2022 at Cape George and Adelma Beach. Working on WDFW permitting/approval for crab pot removal. Working on developing an ROV survey protocol. Nam is willing to help.

The MRC voted to take on storm surge monitoring as a new project.
